# Childcare Sufficiency Assessment Progress report and Action Plan update 2015-16

*Completed in partnership with the Children & Young People's  
Partnership and the Family Information Service*



## Introduction

---

The Vale of Glamorgan Council carried out its third full Childcare Sufficiency Assessment in 2013 to meet the duties under the Childcare Act 2006. This required every local authority to ensure there is sufficient childcare to enable parents to work or undertake education or training in order to make the transition to work.

### 1.1 Aims and Objectives

Sufficient childcare, in Section 6 of the 2006 Act, is defined as 'sufficient to meet the requirements of parents in [the local authority's] area who require childcare in order to enable them –

- a To take up, or remain in, work, or
- b To undertake education or training which could reasonably be expected to assist them to obtain work.

In determining whether provision of childcare is sufficient a local authority:

- a Must have regards to the needs of parents in their area for-
  - The provision of childcare in respect of which the childcare element of the working tax credit is payable, and
  - The provision of childcare which is suitable for disabled children
  - The provision of childcare involving the use of the Welsh language.

### 1.2 The Childcare Sufficiency Duty

The sufficiency data relates to the formal childcare sector, in particular registered day care or sessional care offered by childminders, day nurseries, pre-school playgroups, out of school childcare and maintained school nursery classes offering the free flexible entitlement.

## Update on Gap Analysis 2014-15

Regarding the **Geographical gap** which last year reported that Cowbridge has one of the highest numbers of places and highest vacancy rates, these still remains in 2015-16.

In relation to the **Specific Needs Gap**, the Disability Teen Scheme which run's during the school holidays for young people aged 12-19years is being overseen by the Vale's play team, waiting on Welsh Government prior to looking to re-commission the service next year.

Assisted Places continue to be offered to low income families, children in need and children with disabilities and/or additional needs.

- The total number of children who benefitted from attending a pre-school childcare placement has risen from **35** in 2014-15 to **52** in 2015-16, an increase of **49%**
- The total number of children who benefitted from attending an out of school childcare placement has also risen from **38** in 2014-15 to **68** in 2015-16, an increase of **79%**

Regarding the **Income gap**, Family Information Service received 131 enquiries (over the past year) for information on financial help with childcare / childcare voucher scheme / financial and legal information.

New [FIS web page](#) dedicated to financial help for parents and is linking to the Money Advice Service, Tax Free Childcare Service etc.

JCP sessions for lone parents were on hold from March 15 – Feb 16 due to fire at Barry JCP. Now holding weekly sessions and FIS Outreach Officer attends these, averaging **10** lone parents per week.

In relation to the **Time Gap**, the Out of School Childcare Grant has helped to sustain **12** out of school childcare settings, 2 of which are through the medium of welsh.

**2** new out of school provisions have been set up: an afterschool club, which currently supports 8 – 10 children and holiday club which currently supports 16 children both within Ysgol Y Deri supporting children with disabilities and/or additional needs.

**Type gaps** – the 2014-15 report stated that there was a gap in Welsh medium childcare. A new holiday provision was set up in 2014-15

The establishment of the care scheme has been very well received amongst parents of children in Welsh-medium primary education in the Vale, as well as some visitors to the area during school holiday periods.

Summer 2015 was especially busy, with an average of 22 children attending every day.

Since February 2015:

- 100 families have accessed the service
- 701 childcare places have been accessed

Demographic:

- 65% are from the Barry area
- 75% of the children are from non-Welsh speaking families

The Welsh medium afterschool club set up in 204/15, has also seen an increase in children attending during 2015-16 – see tables below.

## Supply of registered childcare

### Number of Registered Providers

As of March 2016, there are a total of **286** registered childcare providers in the Vale of Glamorgan. All of these settings qualify for people to be able to claim the childcare element of Working Tax Credit. There has been an overall increase of **2** registered providers.

These are broken down as follows:

- **192** Childminders (191 in March 2015)
- **20** After school clubs (20 in March 2015)
- **10** Breakfast clubs (9 in March 2015)
- **15** Holiday care schemes (14 in March 2015)
- **16** Day nurseries (18 in March 2015)

- **24** Playgroups (23 in March 2015)
- **6** Cylchoedd Meithrin (6 in March 2015)
- **3** Crèches (3 in March 2015)

### Number of Registered Places

As of March 2016, there are **4,106** registered childcare places in the Vale of Glamorgan. Therefore, **4,106** childcare places are eligible for parents to claim the childcare element of Working Tax Credit. These are broken down as follows:

- Childminders **1,043** places (25%)
- After school clubs **620** places (15%)
- Breakfast clubs **253** places (6%)
- Holiday care schemes **492** places (12%)
- Day nurseries **932** places (23%)
- Playgroups **597** places (15%)
- Cylchoedd Meithrin **124** places (3%)
- Crèches **45** places (1%)

One quarter of childcare places are with childminders and almost one quarter are in day nurseries.

### Gains and losses

Since the last review in March 2015, there has been an overall decrease of **83** registered childcare places. This is broken down as follows:

#### Childminders

There has been an increase of **1** childminder and **5** places.

#### Day nurseries

There has been a decrease of **2** day nurseries and **68** childcare places. St Illtyd's Day Nursery in Llantwit Major and Kiddywinks Day Nursery in Wenvoe have both closed.

#### Crèche

There has been no change in crèches.

#### Sessional Care

There has been an overall decrease of **26** places. Little People's Playgroup closed in Gibbonsdown. However, **2** playgroups have registered – Bumble Bees Playgroup in Gibbonsdown and Red Robin Playgroup in Cadoc. The decrease in places is within existing settings.

#### Out of school care

There has been an overall increase of **6** places:

### [Holiday Care Schemes.](#)

There has been an increase of **30** places as Cynllun Ysgol Nant Talwg registered in Illtyd ward, Barry. This is a Welsh medium scheme.

### [After School Clubs.](#)

There has been a decrease of **4** places. Nightingales After School Club (St Josephs) has registered in Dinas Powys and Llantwit Major After School Club has deregistered and is running as an unregistered setting.

### [Breakfast Clubs:](#)

There has been a decrease of **20** places. Nightingales Breakfast Club (St Josephs) has registered, providing **10** new places. However, the overall decrease in the number of places is within existing settings.

## **Childcare Sufficiency Assessment in 2016-17**

Discussions will shortly be held with Early Years Development and Childcare Partnership colleagues regarding a full Childcare Sufficiency Assessment (CSA) 2016-17 and how this will take shape.

### [Some examples for consideration for the CSA in 2016 - 17](#)

Housing supply - further phases to existing developments are planned to take place during 2016 – 2021 in Barry, Cowbridge, Penarth, Llantwit Major, Rhoose and Dinas Powys which will need considering in terms of the possibility of additional childcare.

Aston Martin is to build its new luxury car in St Athan, creating 750 highly-skilled jobs. Recruitment for these jobs is in the planning process with an open day scheduled for Wednesday 30<sup>th</sup> March 2016. Additional childcare may be required in the area depending if some of the workforce will re-locate to St. Athan or in the surrounding area.

Consultations with parents/prospective parents, children & young people, stakeholders, childcare providers and employers will also take place via a variety of means. These will form a basis for the childcare already supplied with development of new provision or extension within existing provision.
