I am grateful to the efforts being made by partners to ensure that the strategy is responsive to the needs of the children and young people and that their views will help influence the strategic and operational priorities of partner organisations.

What is participation?

2.1. Definition & Policy Context

Participation is a fundamental right, which is set out in the United Nations Convention on the Rights of the Child (UNCRC), ratified by the UK Government in 1991. The principle of participation is contained in Article 12 and is closely linked to freedom of expression and the right to information:

“States Parties shall assure to the child who is capable of forming his or her own views the right to express those views freely in all matters affecting the child, the views of the child being given due weight in accordance with the age and maturity of the child”

Article 12, UNCRC, 1989

The Welsh Assembly Government ran a competition to find a sound bite for the definition of participation. The winning entry was adopted by the Welsh Assembly Government and the Children and Young People’s Participation Consortium for Wales: **“Participation means that it is my right to be involved in making decisions, planning and reviewing an action that might affect me. Having a voice, having a choice.”**

The Welsh Assembly Government is committed to driving forward the principles of Article 12 across Wales thus ensuring that all children and young people aged 0-25 have opportunities to contribute to and have their voices heard in decision-making on issues which impact on their lives. This commitment has been reinforced in various Assembly Government strategic policies such as the Extending Entitlement¹ which sets out ten entitlements that reflect many similarities with the UNCRC, including the young people’s right to participate. Participation has been given statutory basis under the Children Act 2004, therefore embedding it as the basis of all their work for children and young people in Wales.

Guidance required that each local authority and its partners made 3-year strategic arrangements through their Children and Young People’s Plans. These Plans aim to ensure that all children and young people in Wales:

- having a flying start in life;
- have a comprehensive range of education and learning opportunities;
- enjoy the best possible health and are free from abuse, victimisation and exploitation;
- have access to play, leisure, sporting and cultural activities,
- are listened to, treated with respect, and have their race and cultural identity recognised;
- have a safe home and community which supports physical and emotional wellbeing;
- are not disadvantaged by poverty.

Welsh Policy also saw the establishment of an independent Children's Commissioner who 'champions' children's rights in Wales². The Commissioner has powers to review the effect of policies on, and the delivery of services to, children and young people. Based on their views, the Commissioner can consider anything affecting young people in Wales with an obligation to have regard to the UNCRC when exercising his duties. The Welsh Assembly has also made arrangements on various levels to have the voices of young people heard. Examples of this are:

- Funky Dragon – the Children and Young People's Assembly for Wales informs the Assembly Government directly what they think of key policies that affect them.
- Youth Forums based in most local authorities who aim to make local organisations and services listen to the views of young people and take them into account when making decisions.
- School Councils, whereby young people are involved in the day-to-day running of the schools and school policies. This has been a statutory requirement in Wales through the School Councils (Wales) Regulations 2005.



2.2. Benefits of Participation



The benefits of participation are numerous and suggest that involvement in participatory activities can have a significant impact on children and young people, organisations and council departments and the communities they live in. They include: the development of a sense of belonging and ownership; influence what their service or project does; learn new skills; gain a sense of achievement; recognition that their views and opinions matter; and an increase in self confidence of the children and young people.

On behalf of the Welsh Assembly Government York Consulting LLP conducted a research project into the benefits of children and young people's participation in Wales in 2008³. This

research reviewed 30 sources of literature which highlighted good practice around the participation of children and young people. The review found that there are a number of drivers for participation:

- promoting children and young people's rights;
- strengthening citizenship and democratic processes;
- schools/ organisations and community improvement;
- and as a means of improving children and young people's lives.

The benefits of participation activities were also felt by other groups including staff, organisations and parents. The participation of children and young people brought new perspectives to service development and challenged attitudes around children and young people. It also led to positive tangible outcomes in terms of improvements in the physical environment. The benefits for children and young people included improvements in their self confidence and in their relationships with others. The research also found that particular skills of children and young people were also developed through participation activities, these included decision-making skills as well as understandings of decision-making processes.

2.3. Models of Participation

There are a number of models of participation in existence which describe levels of participation and involvement of children and young people. One of the most well known models is Hart's ladder of Participation⁴, which is illustrated in the form of a ladder with eight rungs from manipulation on the first step to equal partnership; where children, young people and adults share the decision-making at the top. The first three rungs are mostly considered as non-participation. The ladder assumes that some levels of participation are more meaningful than others and that it is always better to work towards increasing the levels of participation.

Treseder⁵ developed an alternative model which recognises that different types of involvement are valid for different children and young people and organisations at different times. His model moves away from Hart's hierarchical model, displaying the degrees of participation in a circular layout.

3 Participation in the Vale of Glamorgan

3.1. Vision and aims of the Participation Strategy

The aim of the participation strategy is to build greater opportunities for participation of children and young people in the Vale of Glamorgan. In order to achieve this aim, we will:

Build a culture that supports and values the participation of children and young people.

Develop structures that support children and young people's participation in key systems and processes of all partners including budget monitoring, finance and reviewing resources; to ensure that their planning and service delivery takes account of children and young people's perspectives.

Strengthen practice by improving our ways of engaging and working with children and young people to support their participation individually and as a group.

Establish monitoring and review processes that allow evaluation of the impact of children and young people's participation in decision-making processes, and the outcomes for children and young people.

Establish effective communication systems between the Children and Young People's Partnership, local community groups, the Vale Youth Forum, school councils and special interest and minority groups.

3.2. Background to Participation in the Vale of Glamorgan

Current levels of participation within the Vale of Glamorgan have been reviewed as part of the Participation Strategy development. The Young People's Participation Task Group carried out a SWOT analysis around participation of young people in the Vale in March 2008, they identified the following issues:

The Vale of Glamorgan Children and Young People's Partnership has adopted Treseder's model of participation and therefore endeavours that all decision-making that affects children and young people should aim to achieve the fullest level of participation that is appropriate. Nevertheless, taking into consideration that the degrees of their involvement can vary from situation to situation, however prioritising children and young people's sense of achievement whilst respecting their choice of involvement. The model is illustrated in the diagram below.




Fig.1. Treseder's model of participation

Activities have also been carried out to establish participation practices amongst local partner organisations. In March and April 2008, all partners of the Vale of Glamorgan Children and Young People's Partnership were asked to complete a questionnaire exploring their participative activities with regards to children and young people. The research identified that the views of children and young people do play a role within the organisations questioned. The responses showed that children and young people do not seem to be directly involved in decision-making, although they are actively consulted with over service delivery and their views about current situations. It can be seen as very positive that no organisation replied that the views of children and young people are not considered in their decision-making processes. The variety of answers recognised that the situation varies across organisations. Further discussion with those organisations that are more advanced in terms of participation practice could lead to some good practice examples being shared.

A consultation activity was also conducted with groups of young people at Local Democracy Week events in 2008. The findings showed that the views of young people in the Vale of Glamorgan do not always play a major role in the decision-making process within the schools they attend and the communities they live in. They also show that young people feel that they are not consistently consulted on the quality of service delivery within schools and communities. It can be seen as very positive that 44% of the young people surveyed knew what their school council had achieved, however answers highlighted that 36% feels the opposite. Young people also suggested that "negative attitudes from adults" was the main barrier from preventing them to getting involved. They also identified an extensive list of ideas and suggestions on how to get involved more within their schools and communities.

Children and young people have been listened to and supported by several activities which represent best practice and value for money in the Vale of Glamorgan:

Local Democracy Week Local Democracy Week is a national campaign designed to encourage young people to become more aware of and involved with their council. The campaign was devised by the Local Government Association and operates throughout the UK. Nearly 500 young people have attended 'Youth Question Time' events and nearly 300 young people have taken part in the on-line activity "I'm a councillor get me out of here". Over 500 young people have registered to vote following a series of road shows held at secondary schools around the Vale of Glamorgan.

Youth PACTs project was funded by Safer Vale from 1st October 2007 to 31st March 2008. This project provides young people with an opportunity to voice concerns and issues about their community. This project was delivered in partnership with The Vale of Glamorgan Youth Service, South Wales Police, Community Focussed Schools, the Vale Youth Forum, The Pulse Street Detached Youth Work Team, the Neighbourhood Policing Teams and voluntary youth provisions. The project is still being carried on in schools through the co-ordination of partners.

3.3 Objectives of the Participation Strategy

Children and young people are involved in a variety of ways in researching local need via workshops, Communities that Care surveys and use of Viewpoint interactive surveys. One of the criteria for Cymorth funded projects is that each project has participation processes in place and the children and young people using the service have influenced the delivery of the project.

It is acknowledged that participation for 0-10 year olds is underdeveloped in the Vale of Glamorgan, however many services have established excellent methods of involving children in developing their services. The Children and Young People's Partnership will employ a Children's Participation worker to develop consistency in participation for all age groups. The Vale Youth Forum is a registered independent charity operating for over 10 years, specifically dedicated to encouraging the active participation of young people in all aspects of life in the Vale of Glamorgan. The Forum is seeking to employ a coordinator who will build capacity with young people and partners, supporting local and national strategic objectives. Thereby, promoting and ensuring that all young people have a collective voice and much opportunity to influence decision-making in service delivery and in communities in which they reside. Through every aim and action within the strategy all partners will adhere to the quality standards for Safeguarding and Child Protection as highlighted within the All Wales Child Protection Procedures 2008 and policies as set out in by the Vale of Glamorgan Council.

Outlined below are commitments that all organisations and partners should support as part of this shared Participation Strategy for children and young people in the Vale of Glamorgan. The following programmes or projects are meeting some of the objectives of Core Aim5 and the priorities of the Vale of Glamorgan Children and Young People's Plan:

3.3.1 Pupil Participation

Aim: To develop and support primary and secondary school council's structures within the Vale of Glamorgan to increase pupil participation, motivation and engagement thus encouraging pupil involvement in school decision-making processes.

Objectives:

- To obtain some consistency in the work of all primary and secondary school councils operating within the Vale of Glamorgan. E.g. all election campaigns to vote a new school council is undertaken in the same time period.
- To provide a raft of training opportunities and support mechanisms for school council pupils and teachers.
- To enable all primary and secondary school councils within the Vale to share good practice and enable them to collectively lobby to improve pupil participation systems.

- To enable all primary and secondary school councils in the Vale to exercise active links with the Vale Children and Young People's Partnership, their local forums and community groups and to wider participation bodies and events.

Outcomes and benefits:

- Pupils have the skills needed to participate effectively. More and better support and resources are provided for school council pupils and teachers.
- Everyone in the school community feels valued, respected and included thus enjoying school life better and reducing possible school exclusions.
- Pupil participation is motivating and fun and helps pupils to feel engaged.
- School policies and services are more effective and efficient if they are planned, delivered and evaluated on the basis of the identified needs of the pupils, with their involvement.
- School Councils (Wales) Regulations 2005 are adhered to.
- The school community benefits from changes made such as healthier food in the canteen, better equipment, less bullying, etc.
- Have access to training packages and opportunities and up-to-date information.
- PSE targets to empower pupils to participate in their communities as active citizens are possible met.
- School councils will be better prepared for Estyn inspections.



3.3.2. Community Participation

Aim: To establish a sustainable Forum of young people that represent their communities or out of school group.

Objectives:

- To obtain some consistency in the participation work of all agencies and services operating within the Vale of Glamorgan with a young person focus, whilst encouraging partnership working.
- To provide participation training opportunities and support mechanisms for young people and workers.
- To obtain external funding to prioritise and target special interest and minority groups of young people to enable and empower them to collectively lobby to improve youth services and address gaps in provision.
- To enable the Vale Youth Forum to exercise active links with the Vale Children and Young People's Partnership, their local community groups e.g. Gibbonsdown & Court Communities First Youth Forum, Youth PACTs and to wider participation bodies and events.
- To support and encourage children and young people initiated participatory activities.

Outcomes and benefits:

- A sustainable mechanism for all groups of young people to be involved in active citizenship activities.
- Support and resources provided for out of school and user youth groups.
- Prevent alienation and anti-social behaviour displayed as young people have an opportunity to have a voice and a choice about their community.

- Community initiatives are more effective and efficient if they are planned, delivered and evaluated on the basis of the identified needs of the young people, with their involvement.
- Improved social cohesion.
- Increasing the numbers of young people 18-25 who choose to vote in local and general elections.
- Engagement and involvement of minority groups of young people in community and youth participation activities.

3.3.3. Vale Youth Council

Aim: The long term aim is to establish a Vale Youth Council which will be a democratically elected body to debate, influence and scrutinise Council issues which directly affect young people.

Objectives:


- To work with young people from various participation projects, the Children and Young People's Partnership and the leadership of the council to develop a Vale Youth Council Constitution which allows true influence in the decision-making processes.
- To set up a process of elections to democratically elect young people to the Vale Youth Council.

Outcomes and benefits:

- Inform young people about politics and how decisions are made.
- Provide a mechanism for local politicians to be more representative of and accountable to young people.
- Create opportunities for young people to be involved in the democratic process.
- Increase the numbers of young people aged 18-25 years choosing to vote in local and national elections.
- The recognition that Council youth initiatives are more effective and efficient if they are planned delivered and evaluated on the basis of the identified needs of the young people, with their involvement.
- Improved social cohesion and civil renewal.
- Raise the profile of the Vale Council's investment in youth Participation nationally & internationally.

The attached action plans refer to the work that needs to be developed to support the implementation of the Participation Strategy and the priorities identified in the Children and Young People's Plan. They will be monitored and evaluated by the Vale of Glamorgan Children and Young People's Partnership together with stakeholders and children and young people. The plans are SMART and will be reviewed annually.

3.4. Local Participation Structure



4. Monitoring & Evaluation – National Standards of Children and Young People's Participation

From commonly agreed 'core principles' of participation, the Children and Young People's Participation Consortium and the Participation Unit have developed National Standards for Children and Young People's Participation i.e. quality standards that can provide a means for inspecting and assessing participatory practice.

The National Standards for Children and Young People's Participation, adopted by the Welsh Assembly Government and launched in 2007, are standards which children and young people can expect when they are asked to participate. There are 7 standards: Information; It's Your Choice; No Discrimination; Respect; You get Something out of it; Feedback; Improving How We Work.

The Standards aspire to making sure that children and young people have a good, positive and meaningful experience of participation. The ultimate aim of the Standards is to work towards the implementation of the National Children and Young People's Participation Standards across Wales by a process of external assessment against potentially a National Kite-mark (or similar quality assurance scheme), endorsed by the Welsh Assembly Government. The Participation Unit has developed a self-assessment pack to accompany the Participation Standards, which emphasises the importance of good practice and organisations beginning to measure their own performance against them.

The Vale of Glamorgan Children and Young People's Partnership will monitor and evaluate the effectiveness of its Children and Young People's Plan and its Participation Strategy by using the National Standards of Children and Young People's Participation. This will identify if organisations and services improve as a direct result of the participation of children and young people in the Vale of Glamorgan. The strategic management of inspecting against the Standards will be endorsed by a steering group which will include young inspectors.

Having a Voice - Having a Choice

Do we meet your standards?

"We mean making children and young people to participate. 'You' have a right to expect these standards."

"Participation means that it is my right to be involved in making decisions, planning and reviewing any actions that might affect me. Having a voice, having a choice!"



INFORMATION



This means:

- information that is easy to understand for everyone
- adults working with you who know what is going on and are up front and clear.

We will:

- Ensure everyone has enough information to get properly involved
- Let you know what difference you being involved will make
- Inform you about who is going to listen and make changes.

IT'S YOUR CHOICE



This means:

- You choose if you want to get involved or not
- You choose to work on things that are important to you

- Give you enough information and time to decide if this is something you want to do.

- Children and young people are all different but you all have the same right to have a say about the things that matter to you.
- We want everyone to feel welcome and be able to get involved if they want to be.

We will:

- challenge any discrimination
- get in touch with children and young people in lots of different situations
- get you involved in things you want to do;

RESPECT



This means:

- Everyone has a chance to have a say, your opinions are important and we will respect them.

We will:

- Listen to your ideas, views and experiences
- take you seriously and treat you fairly
- work with you to do something about the things you tell us are important
- work with you to help change things for the better.

YOU GET SOMETHING OUT OF IT



This means:

- We want you to enjoy and benefit from taking part
- We know that you have other things to do in your lives as well!
- Making sure that participating is a positive not a negative experience.

We will:

- work in safe, fun, and enjoyable ways
- make the most of what you know
- do positive things that build your confidence
- meet in friendly places that are safe for all young people to use
- value and respect what you have to offer.

FEEDBACK



This means:

- It's really important that you know what difference you have made and how your ideas have been used.

We will:

- keep you up to date with what is happening
- give feedback as soon as possible and in ways that are easy to understand for everyone.

IMPROVING HOW WE WORK



This means:

- We want to learn and get better at the way we work with you.

We will:

- look at the way we work with you and how to improve it

- ask you what has gone well and what needs to change
- make sure your views make a difference to the way we make plans and decisions.



These are the agreed children and young people's participation standards for adults

In addition the partners will make the following pledges to children and young people in the Vale of Glamorgan;

Our pledges:

1. We pledge our information will be provided in appropriate formats/languages and give you enough time which will support children and young people to decide on whether or not they wish to become involved. – This means: ***Any information given will be young people friendly.***
2. We pledge to ensure that all children and young people have the same opportunities to be involved in participative processes irrespective of where they live, their needs or circumstances. – This means: ***To make sure that all under 25s have as many opportunities to be involved with anything in their area.***
3. We pledge to respect and value the contributions of all children and young people, take them seriously and treat them fairly. – This means: ***To respect and value the contributions of everyone.***
4. We pledge that we will at all times endeavour to make sure that children and young people find participating a positive experience and benefit from taking part. – This means: ***To make participation a fun and positive experience.***
5. We pledge we will always keep children and young people informed of what difference they have made and how their ideas have been used. – This means: ***To always keep you updated on how your ideas have helped.***
6. We pledge the way we work with children and young people will get better because we have/will take account of their views. – This means: ***The way we work with you will get better because we listen to your views.***
7. We pledge that we will take account of the views of parents and carers in fulfilling our pledges to children and young people, where appropriate. – ***This means: We will listen to parents and carers in fulfilling our pledges.***
8. We pledge children and young people will be involved in a meaningful way in governance and co-management; budget monitoring, finance and reviewing resources; and staff appointments, where appropriate. – This means: ***To include you in all decisions made.***

Beth yw Cyfranogi?

2.1. Diffiniad & Chyd-destun Polisi

Mae cyfranogi yn hawl sylfaenol, sydd wedi ei nodi yng Nghonfensiwn y Cenhedloedd Unedig ar Hawliau'r Plentyn (UNCRC), a ddilyswyd gan Lywodraeth y Deyrnas Unedig yn 1991. Mae'r egwyddor o gyfranogi yn cael ei sefydlu yn Erthygl 12 ac mae perthynas agos rhyngddi â rhyddid mynegiant a'r hawl i gael gwybodaeth:

"Bydd Partïon y Gwladwriaethau yn sicrhau'r plentyn sy'n alluog i ffurfio ei farn ei hun, yr hawl i fynegi'r farn honno yn rhydd ym mhob mater sy'n effeithio ar y plentyn, gan roi dyledus bwys i farn y plentyn yn unol ag oedran ac aeddfedrwydd y plentyn"

Erthygl 12, UNCRC, 1989

Cynhaliodd Llywodraeth Cynulliad Cymru gystadleuaeth i ddod o hyd i amgyffrediad pobl ynglŷn â'r diffiniad o gyfranogi. Mabwysiadwyd y cynnig llwyddiannus gan Lywodraeth Cynulliad Cymru a Chonsortiwm Cyfranogiad Plant a Phobl Ifanc ar gyfer Cymru: "**Mae cyfranogi yn golygu bod gennyr hawl i gymryd rhan mewn gwneud penderfyniadau, cynllunio ac adolygu gweithred a allai effeithio arnaf. Cael llais, cael dewis.**"

Mae Llywodraeth Cynulliad Cymru wedi ymrwymo i weithredu egwyddorion Erthygl 12 ar draws Cymru gan sicrhau trwy hynny bod cyfleoedd i blant a phobl ifanc hyd at 25 oed ddweud eu dweud ac i gyfrannu at wneud penderfyniadau sy'n effeithio ar eu bywydau. Mae'r ymrwymiad hwn wedi cael ei atgyfnerthu mewn nifer o wahanol bolisiau strategol gan Lywodraeth y Cynulliad, er enghraifft Ymestyn Hawliau¹ sy'n rhestru deg o hawliau sydd mewn llawer ffordd yn debyg i UNCRC, gan gynnwys hawl pobl ifanc i gymryd rhan. Cafodd cyfranogiad sail statudol o dan Ddeddf Plant 2004, a oedd yn cael ei sefydlu ar gyfer holl waith y Cynulliad ar gyfer plant a phobl ifanc yng Nghymru.

Mae canllawiau'n mynnu bod pob awdurdod lleol a'u partneriaid yn gwneud trefniadau strategol 3-blynedd trwy gyfrwng eu cynlluniau Plant a Phobl Ifanc. Mae'r Cynlluniau hyn yn anelu at sicrhau bod pob plentyn a pherson ifanc yng Nghymru:

- yn cael cychwyn cadarn mewn bywyd;
- yn cael ystod eang o gyfleoedd addysgu a dysgu;
- yn profi'r iechyd gorau posibl, yn rhydd o gamdriniaeth, erledigaeth a chambanteisio;
- bod gan y plant fynediad i weithgareddau chwarae, hamdden, chwaraeon a gweithgareddau diwylliannol;
- eu bod yn cael gwrandoedd a'u trin gyda pharch, gan roi cydnabyddiaeth i'w hunaniaeth hiliol a diwylliannol;
- bod ganddynt gartref diogel a chymuned sy'n cynnal eu lles corfforol ac emosiynol;
- nad ydynt yn wynebu anfantais oherwydd tlodi.

Mae Polisi Cymru hefyd wedi gweld sefydlu Comisiynydd Plant annibynnol sy'n hyrwyddo hawliau plant yng Nghymru². Mae gan y Comisiynydd bwerau i adolygu effaith polisiau a darpariaeth gwasanaethau i blant a phobl ifanc. Yn seiliedig ar eu barn, gall y Comisiynydd ystyried unrhyw fater sy'n effeithio ar bobl ifanc yng Nghymru gyda dyletswydd i dalu sylw i'r UNCRC wrth gyflawni ei ddyletswyddau. Mae Cynulliad Cymru hefyd wedi gwneud trefniadau ar wahanol lefelau i sicrhau bod lleisiau pobl ifanc yn cael eu clywed. Enghreifftiau o hyn yw:

- Mae'r Ddraig Ffynsi – Cynulliad Plant a Phobl Ifanc Cymru yn rhoi gwybod yn uniongyrchol i Lywodraeth y Cynulliad beth y maent yn ei feddwl o bolisiau allweddol sy'n effeithio arnynt.
- Fforymau leuenctid sydd ar gael yn y rhan fwyaf o awdurdodau lleol ac sy'n anelu at wneud i sefydliadau a gwasanaethau lleol wrando ar farn pobl ifanc a'u cymryd i ystyriaeth wrth wneud penderfyniadau.
- Cynghorau Ysgolion, lle mae pobl ifanc yn cymryd rhan mewn rhedeg yr ysgol a pholisiau'r ysgol o ddydd i ddydd. Bu hyn yn ofyniad statudol yng Nghymru trwy Reoliadau Cyngor Ysgolion (Cymru) 2005.



2.2. Buddion Cyfranogi



Mae buddion niferus i gyfranogiad ac mae hynny'n awgrymu bod cymryd rhan mewn gweithgareddau cyfranogol yn gallu cael effaith sylweddol ar blant a phobl ifanc, sefydliadau ac adrannau o'r cyngor yn ogystal â'r cymunedau y maent yn byw ynddynt. Mae'r buddion yn cynnwys: datblygu ymdeimlad o berthyn ac o berchenogaeth; dylanwadu ar yr hyn y mae'r gwasanaeth neu'r prosiect yn ei wneud; dysgu sgiliau newydd; cael ymdeimlad o gyflawni; sylweddoli bod barn a safbwytiau'r unigolyn yn cyfrif; a chynnydd yn hunanhyder y plant a'r bobl ifanc.

Ar ran Llywodraeth Cynulliad Cymru cynhaliodd York Consulting LLP brosiect yn ymchwilio i'r buddion a gododd o gyfranogiad plant a phobl ifanc yng Nghymru yn 2008³. Roedd yr ymchwil yn adolygu 30 ffynhonnell o lenyddiaeth a oedd yn amlygu arferion da ym maes cyfranogiad plant a phobl ifanc. Daeth yr adolygiad i'r casgliad bod nifer o ffactorau yn hyrwyddo cyfranogiad:

- hybu hawliau plant a phobl ifanc;
- cryfhau dinasyddiaeth a phrosesau democrataidd;
- gwella ysgolion, sefydliadau a chymunedau;
- yn ogystal â bod yn ffordd o wella bywydau plant a phobl ifanc.

Roedd grwpiau eraill hefyd yn gweld budd mewn gweithgareddau cyfranogi gan gynnwys staff, sefydliadau a rhieni. Roedd cyfranogiad plant a phobl ifanc yn rhoi golwg newydd i bobl ynglŷn â datblygu gwasanaethau ac yn herio agweddu a gweladwy o ran gwella'r amgylchedd ffisegol. Roedd y buddion i blant a phobl ifanc yn cynnwys gwelliant yn eu hunanhyder ac yn eu cydberthynas gyda phobl eraill. Daeth yr ymchwil hefyd i'r casgliad bod rhai o sgiliau penodol plant a phobl ifanc wedi cael eu datblygu trwy weithgareddau cyfranogi, roedd hyn yn cynnwys sgiliau gwneud penderfyniadau yn ogystal â'u dealltwriaeth o brosesau gwneud penderfyniad.

2.3. Modelau o Gyfranogi

Mae nifer o fodelau cyfranogi yn bodoli ac yn disgrifio lefelau cyfranogiad a chysylltiad plant a phobl ifanc. Un o'r modelau mwyaf cyfarwydd yw ysgol Cyfranogiad Hart⁴. Mae'r model hwn ar ffurf ysgol wyth ffon yn codi o drin gwybodaeth ar y ffon gyntaf i bartneriaeth gydradd; lle mae plant, pobl ifanc ac oedolion yn gwneud penderfyniadau gyda'i gilydd ar y gris uchaf. At ei gilydd, nid ystyrir bod tair ffon gyntaf ysgol yn gyfranogiad gwirioneddol. Mae'r ysgol yn cymryd bod rhai lefelau o gyfranogiad yn fwy ystylon nag eraill a'i bod bob amser yn well symud tuag at gynyddu lefelau cyfranogiad.

Datblygodd Treseder⁵ fodel amgen sy'n cydnabod bod gwahanol fathau o gyfranogiad yn ddilys ar gyfer gwahanol blant a phobl ifanc a gwahanol sefydliadau ar adegau gwahanol. Y mae ei fodel ef yn symud oddi wrth fodel hierarchaeth Hart, gan ddangos y graddau o gyfranogi ar ffurf cylch.

Datblygu strwythurau sy'n cefnogi cyfranogiad plant a phobl ifanc yn systemau a phrosesau allweddol yr holl bartneriaid gan gynnwys monitro cylideb, cylid ac adolygu adnoddau; er mwyn sicrhau bod y gwaith cynllunio a'r gwasanaethau a ddarperir ganddynt yn cymryd safbwytiau plant a phobl ifanc i ystyriaeth.

Atgyfnerthu arferiad trwy wella ein dull o ymgysylltu a gweithio gyda phlant a phobl ifanc er mwyn cefnogi eu cyfranogiad fel unigolion ac fel grŵp.

Sefydlu prosesau monitro ac adolygu sy'n caniatáu gwerthuso effaith cyfranogiad plant a phobl ifanc mewn prosesau llunio penderfyniadau, ac yn caniatáu gwerthuso'r canlyniadau i blant a phobl ifanc.

Sefydlu systemau cyfathrebu effeithiol rhwng y Bartneriaeth Plant a Phobl Ifanc, grwpiau cymunedol lleol, Fforwm Ieuenciad y Fro, cynghorau ysgol, grwpiau diddordeb arbennig a grwpiau lleiafrifol.

3.2. Y Cefndir i Gyfranogiad ym Mro Morgannwg



Mae gweithgareddau wedi cael eu cynnal hefyd i sefydlu arferion cyfranogi ymhliith cyrff lleol sy'n bartneriaid. Ym Mawrth ac Ebrill 2008, gofynnwyd i holl bartneriaid Partneriaeth Plant a Phobl Bro Morgannwg gwblhau holiadur yn archwilio eu gweithgareddau cyfranogol mewn perthynas â phlant a phobl ifanc. Roedd yr ymchwil yn dangos bod lle i farn plant a phobl ifanc o fewn y sefydliadau a holwyd. Roedd yr ymatebion yn dangos nad ymddengys bod plant a phobl ifanc yn cymryd rhan uniongyrchol mewn gwneud penderfyniadau, er yr ymgynghorir yn weithredol gyda hwy ynglŷn â darparu gwasanaethau a'u bod yn cael eu holi am sefyllfaeodd cyfredol. Y mae'n beth cadarnhaol iawn na ddywedodd yr un sefydliad nad ydynt yn ystyried barn plant a phobl ifanc yn eu prosesau o wneud penderfyniadau. Mae'r amrywiaeth o atebion a gafwyd yn adlewyrchu'r ffaith bod y sefyllfa'n amrywio ar draws y gwahanol sefydliadau. Gallai cynnal trafodaethau pellach gyda'r cyrff sydd fwy ar y blaen o safbwyt arferion cyfranogi arwain at rannu rhai enghreifftiau o arferion da.

Peth arall a wnaethwyd oedd cynnal gweithgaredd ymgynghori gyda grwpiau o bobl ifanc yn ystod Wythnos Ddemocratiaeth Leol yn 2008. Mae'r casgliadau hefyd yn dangos bod pobl ifanc yn teimlo nad ymgynghorir gyda hwy yn gyson ynglŷn ag ansawdd y gwasanaeth a ddarperir o fewn ysgolion ac yn y cymunedau. Gellir ystyried ei bod yn gadarnhaol iawn bod 44% o'r bobl ifanc a holwyd yn gwylod beth yr oedd eu cyngor ysgol wedi ei gyflawni, ond roedd yr atebion yn amlyu'r ffaith bod 36% yn teimlo'n groes i hynny. Awgrymodd pobl ifanc hefyd mai "agweddu negyddol oedolion" oedd y prif rwystr iddynt gymryd rhan. Cafwyd rhestr helaeth ganddynt o syniadau ac awgrymiadau ynglŷn â sut i fod yn fwy cyfrannog yn eu hysgolion a'u cymunedau.

Mae plant a phobl ifanc hefyd wedi cael gwrandawiad a chefnogaeth mewn nifer o weithgareddau sy'n cynrychioli arferion gorau a gwerth am arian ym Mro Morgannwg:

Wythnos Ddemocratiaeth Leol Mae'r Wythnos Ddemocratiaeth Leol yn ymgyrch genedlaethol i annog pobl ifanc i fod yn fwy ymwybodol o'u cyngor ac i gymryd rhan. Mae dros 500 o bobl ifanc wedi cofrestru i bleidleisio yn dilyn cyfres o sioeau teithiol a gynhalwyd mewn ysgolion uwchradd ym Mro Morgannwg.

Cytundeb Ieuencid Mae hwn yn brosiect a ariannwyd gan Fro Fwy Diogel rhwng 1 Hydref 2007 a 31 Mawrth 2008. Mae'r prosiect yn rhoi cyfle i bobl ifanc fynegi eu pryderon ac i godi materion ynglŷn â'u cymuned. Darparwyd y prosiect mewn partneriaeth â Gwasanaeth Ieuencid Bro Morgannwg, Heddlu De Cymru, Ysgolion Bro, Ffowrwm Ieuencid y Fro, Tim Gwaith Ieuencid y Pulse Street Detached, y Timau Plismona yn y Gymdogaeth a darparwyr gwasanaethau ieuencid gwirfoddol. Mae'r prosiect yn dal i redeg mewn ysgolion trwy gydwethrediad partneraid.

Un o feini prawf y prosiectau sy'n cael eu cyllido gan Cymorth yw bod gan bob prosiect brosesau cyfranogi a bod y plant a'r bobl ifanc sy'n defnyddio'r gwasanaeth wedi dylanwadu ar ddarpariaeth y prosiect.

Yr ydym yn cydnabod nad yw cyfranogiad plant 0-10 oed wedi datblygu yn ddigonol ym Mro Morgannwg, ond mae llawer o wasanaethau wedi sefydlu dulliau rhagorol o gael plant i gyfrannu at ddatblygu eu gwasanaethau. Bydd y Bartneriaeth Plant a Phobl Ifanc yn cyflogi gweithiwr Cyfranogiad Plant i ddatblygu cysondeb yng nghyfranogiad pobl o bob grŵp oedran. Mae Fforwm Ieuengtid y Fro yn elusen gofrestredig annibynnol sydd wedi bod yn gweithredu am dros 10 mlynedd, gan ymroi'n benodol i annog pobl ifanc i gyfranogi'n weithredol ym mhob agwedd ar fywyd ym Mro Morgannwg. Mae'r Fforwm yn dymuno cyflogi cydgysylltydd a fydd yn adeiladu capaciti gyda phobl ifanc a phartneriaid, i gefnogi amcanion strategol lleol a chenedlaethol. Gan hynny, bydd yn sicrhau a hyrwyddo llais cyfun pobl ifanc ac yn rhoi cymaint â phosibl o gyfle iddynt dylanwadu ar wneud penderfyniadau ar gyfer darparu gwasanaethau a'r penderfyniadau a wneir yn y cymunedau lle maent yn byw. Ym mhob un o nodau a chamau gweithredu'r strategaeth bydd yr holl bartneriaid yn glynw at y safonau ansawdd ar gyfer Diogelu ac Amddiffyn Plant fel y nodir yng Ngweithdrefnau Amddiffyn Plant Cymru Gyfan 2008 a'r polisiau a restrir gan Gyngor Bro Morgannwg.




