9. Annual Report/Performance Management/Feedback on LSB support team meeting	
Francesca gave an update on the drafting of the Annual Report. A number of completed templates have been received from the Partnerships.	
Feedback was given on the LSB support meeting that took place in Builth Wells. WG gave an update on progress by each Local Authority in producing a Single Integrated Plan. Feedback was also given on the findings from each Local Authority regarding producing a Unified Needs Assessment. Participants were advised that two main approaches had been adopted. For the majority of Authorities it involved assessing data for the Local Authority and this is described as a situational analysis. For others it involved looking at what interventions could be put in place and this is described as a response analysis.	
With regard to the situational analysis, some used population indicators first and then went into the analysis. Others focused on an amalgamation of existing data and the situational analysis was small.	
A report to feedback on a study analysing how each authority has produced its SIP and need's assessment has been produced. The report makes several recommendations regarding producing a needs assessment. Recommendations include; that it is important to incorporate more qualitative data, to focus on a smaller number of	

data sets and to work with partners and other data analysts from	
LSBs to ensure the Unified Needs Assessment is sustainable.	
The report also recommends that Welsh Government provide feedback on producing Unified Needs Assessments and provide case studies of best practice.	
10. Exchange of Information	
Rachel Connor highlighted a new WG consultation called 'Continuity and Change – Refreshing the Relationship between Welsh Government and the Third Sector in Wales'. A consultation event will be held locally on the 20 <sup>th</sup> June 2013 at Barry Community Enterprise Centre. Rachel asked for feedback highlighting the role of local CVC's. Invites to the event to be sent out soon.	ALL
