# THE VALE OF GLAMORGAN COUNCIL (A4050 PORT ROAD (PART) 40MPH AND 50MPH SPEED RESTRICTION, AMENDMENT AND REVOCATION) ORDER 2022

- 1. On the 15<sup>th</sup> November 2022 the Vale of Glamorgan Council in exercise of its powers under Sections 1, 2 and 84 of the Road Traffic Regulation Act 1984 and of all other enabling powers made an Order the general effect of which is as described in the Schedules below.
- 2. The Order will come into operation on the 21<sup>st</sup> November 2022 or on the date that the signs and road markings are in place, whichever is the later and shall be referred to as The Vale of Glamorgan Council A4050 Port Road (Part) 40mph and 50mph Speed Restriction, Amendment and Revocation) Order 2022
- 3. A copy of the Order and plans showing the affected area may be inspected on the Council's website at www.valeofglamorgan.gov.uk.
- 4. If you wish to question the validity of the Order or any provisions contained therein on the grounds that they are not within the powers conferred by the above Act or on the grounds that any requirement of the same or that any instrument made under it has not been complied with in relation to the Order, you may within six weeks from the 21<sup>st</sup> November 2022 apply to the High Court for this purpose.

### **SCHEDULE 1**

# New 40mph Speed Restriction Route A4050, Port Road (part)

From its junction with the Culverhouse Cross Interchange roundabout in a generally southerly direction to the St Andrews Road roundabout for a distance of approximately 2800 metres.

### **SCHEDULE 2**

# Consolidation/Amendments to existing Traffic Regulation Orders Route A4050, Port Road (part)

## 50 mph Speed Restriction

From its junction with the St Andrews Road roundabout in a generally southerly direction to a point approximately 270 metres north west of the junction with the A4231 Barry Docks Link Road a distance of approximately 1020 metres.

### 40 mph Speed Restriction

From a point 270 metres north west of the junction with the A4231 Barry Dock Link Road, in a generally south westerly direction to the Waycock Cross Roundabout a distance of approximately 4150 metres.
