It is intended to help **overcome the additional barriers** that prevent learners from disadvantaged backgrounds achieving their full potential.

As part of this session, you will receive a copy of the CSC **self-evaluation toolkit** for use in schools and a copy of the regional **guidance for effective PDG spending**.


- Understand the **achievement of eFSM learners** in your school
