Race Equality Briefing for School Governors

The Vale of Glamorgan Council Equalities Department recently commissioned Race Equality First to produce a Race Equality Briefing for School Governors. The briefing paper which has been distributed to all Chairs, Clerks and Headteachers highlights key areas of Race Equality that governing bodies have a responsibility to comply with.

According to Race Relations Act 1976, as amended, the governing body of a school is ultimately responsible for

- making sure the school complies with the amended Race Relations Act 1976
- making sure the race equality policy and its procedures are followed.

The duties of schools, as per the Act, are as follows:

The General Duty:

The general duty, as set out in section 71(1) of the Act, says you must have 'due regard to the need':

- to eliminate unlawful racial discrimination
- to promote equality of opportunity
- good relations between persons of different racial groups

Specific Duties

The Race Relations Act 1976 (Statutory Duties) Order 2001 says that the governing body of a school must:

(1) prepare a written race equality policy

(2) assess the impact of its policies on pupils, staff and parents of different racial groups (3) monitor the impact and operation of such policies (4) Publish annually the results of the above monitoring

Race Equality Policy...

is a crucial specific duty to be met. You must have a written race equality policy and review it every three years.

Code of Practice produced by former Commission for Racial Equality (now EHRC) also says: The race equality policy should be a written statement of responsibilities and commitments. It could be linked to an action plan for putting the policy into practice. A good policy would: a. be part of the school's development plan;

b. give details of how the school will put the policy into practice and assess how effective it is; c. clearly define roles and responsibilities, so that people know what is expected of them; and d. explain clearly what the school will do if the policy is not followed. Further advice on what should be included on the policy can be obtained from "The duty to promote race equality, a guide for schools" available on EHRC's website.
