### PTAs and Licensing: the importance of getting it right

Over the last three years new licensing and gambling England and Northern Ireland, works closely with legislation have resulted in significant changes to the licences that a PTA needs for example to hold an event or a raffle. Not having the correct licences in place may lead to problems for the PTA. Failure to obtain the appropriate licence for an event featuring regulated entertainment, the supply of alcohol and/or late night refreshments (such as disco's or summer fairs) could result in a fine of up to £20,000 or six months imprisonment.

The National Confederation of Parent Teacher Associations (NCPTA), a national charity and membership organisation providing support for PTAs and other home school groups throughout Wales,

the relevant regulatory authorities to understand forthcoming changes and to seek specific guidance on how PTA activities are effected. Membership of the NCPTA will ensure that your PTA is aware of pertinent changes to licensing requirements.

### **Education 2015**

Following the advent of the Children and Young People's Plan (CYPP), the education service is no longer obliged to produce a "Single Education Plan." However, in order to make a confident and meaningful contribution to the CYPP and the Council's Corporate Plan, the Council's education service, including schools and their governing bodies, need to be clear about the service's vision, its sense of purpose, the values it wishes to promote, its priorities and the outcomes it wishes to achieve for the children and young people in the Vale.

Accordingly the Learning and Development Directorate has embarked on a process of consulting its own staff and headteacher colleagues on the education service's purpose (mission), the core values the service should exemplify in its work and the main priorities we should aim to promote. The latter clearly needs to be based on an analysis of need and work has taken place to capture the intelligence gained from recent surveys of need and the messages emanating from the wealth of data available to us.

The process of consultation and discussion will result in draft papers which will, within the next few weeks, evolve into a set of succinct statements outlining our service's purpose, values and priorities and will seek to capture the essence of our approach in an overarching vision statement. In order to ensure these statements have meaning, in an operational context, each priority will be linked to a number of outcomes we would wish children and young people in the Vale to achieve. These outcome statements will be critical in guiding and informing our various service units in planning their work and generating their own targets.

Whilst this exercise is critically important for those responsible for delivering the Council's education services it is also essential that the services' key partners are informed about and able to participate in the process. Discussions with elected members, headteachers, governors and young people will be an important ingredient before statements are agreed and acted upon. Hopefully governors of our schools will take a keen interest in this exercise and will provide us with feedback to further inform the process. He then addressed the subject of skills that work for Wales and the initiatives being put into place e.g. 14 -19 Pathways and the Welsh Baccalaureate which will equip future generations with the skills needed to engage fully in society and the workplace in Wales.

> Professor Hawker completed his address by talking about the need for Welsh Assembly Government to look at capacity within the education system to ensure that services offered were the best value for money.

> Dr Martin Price, Chair of VSGA then introduced Richard Gerver (Educator and Adviser to the DCSF, QCA and the Government) who delivered a lively and uplifting keynote presentation entitled 'Leading into the Unknown'.

> Richard challenged us to consider our moral purpose in schools and questioned whether it drives our vision in practice. Are we preparing children and young people effectively for the future?

Schools need to ensure pupils have confidence to express their needs and strengths. He believed that schools should remodel delivery to more appropriately

match what pupils need rather than what teachers want to teach. Learning today for life tomorrow was a key message together with an emphasis for governors and teachers to make learning matter.

Richard's presentation was refreshing and engaging placing a clear focus on putting children at the centre of all we do.

During a break for coffee, governors had the opportunity to network with speakers, officers of the School Improvement Service as well as fellow governors before breaking into groups for two workshops.

One workshop was led by Andy Henderson (Headteacher of Ysgol Hen Felin in Rhondda Cynon Taff) provided an insightful Headteacher's perspective of the School Effectiveness Framework. The School Effectiveness Framework sets out the vision for putting school effectiveness based on tri-level reform into action. Tri-level reform is the whole of the education community (schools, local authorities and the Assembly Government) working collaboratively and in alignment. The Framework describes the key characteristics required to build on existing good practice and improve children's and young people's learning and wellbeing throughout Wales, and each partner's contribution to securing that. Andy updated delegates with progress on the implementation of the Framework since its launch by Jane Hutt (Minister for Children, Education, Lifelong Learning & Skills) at our Governor Conference

The other workshop led by Richard Gerver built on his messages delivered during his earlier keynote presentation.

Richard spoke about his experiences as a Headteacher at Grange Primary School in Long Eaton, Derby and provided examples of 'New Curriculum' initiatives he introduced to improve the school.

Relationships and partnerships were built with the local community, its businesses and organisations to support 'The Grangeton Project'. 'Grangeton' is the school's own town run by the pupils which consists of a newspaper, library, cinema, healthy eating tuck shop, media centre with a television centre and radio station, language café and a museum.

The town also includes 'Grange University' where children have the opportunity to select learning opportunities through a series of workshops that run every Friday morning. Workshops run for the duration of a half term and are accredited against a series of preplanned skills that feed back into the children's learning. Workshops are run by school staff, parents

and local organisations and businesses. Workshops allow the children to develop a portfolio of skills in areas that they are interested in. Every child keeps a record of their workshops and are given a certificate at the end of each workshop block.

The University offers children the chance to develop interests and skills in a number of areas which will helps identify each child's unique talents, some of which, under a conventional curriculum can go undiscovered. Following the workshops everyone came together for the closing presentation. Bryan Jeffreys (Director of Learning & Development) delivered a presentation
