Review of the Year

May 2007

The first meeting of the Forum in 2007/08 took place at the Cory Education Centre, Dyffryn Gardens.

One of the main issues discussed at the meeting was the Council's draft **Rights of Way Improvement Plan**. The three month consultation period for the draft ROWIP led, generally, to a very positive response being received, particularly for the idea of partnership development, especially from Town and Community Councils.

The Countryside Council for Wales also submitted an extremely useful response, which was again included in the information considered by the Forum.

In May the Forum received for information a copy of statutory guidance issued by the Welsh Assembly Government under Sections 147 and 147ZA of the Highways Act 1980 relating to the requirement for local authorities to have

regard to the needs of people with mobility problems when authorising stiles and gates.

Discussion then ensued on the needs of landowners given the specific situation within the Vale which housed a diverse and increasing number of landowners and farmers, both large and small scale. Reference was, however, made to the fact that efforts had been made to address that matter within the draft ROWIP in that, whilst looking at gap, gate, stile in that order the Council recognised the need to consult with and gain agreement from landowners and to work within what was statutory guidance and could not therefore be ignored. The drawing of attention to the following publications, as alluded to in the guidance, was also noted: “By All Reasonable Means: Inclusive Access to the Outdoors for Disabled People”; and Countryside for All Good Practice Guide, extended CD edition, published by the Fieldfare Trust in 2005.

“**Let’s Walk Cymru**” was a new Wales-wide initiative (promoted through Sports Council Wales and supported by WAG and CCW) tasked with increasing the number of people undertaking walking as a regular health benefiting activity. The initiative supported existing physical activity projects as long as they showed additional features in their application for assistance illustrating an extension of the project to include different people, areas or activities.

The Guidance Note submitted to the Forum set out details of the following:

- categories of projects which would be funded;
- eligibility;
- what a grant could / could not be used for;
- details of the amount of grant available (i.e. of up to £10k. per annum);
- timescale.

Further consideration was given to a revised draft outline **Coastal Access Improvement Programme (CAIP)**. The draft document had been amended in the light of comments received, investigation into potential schemes and further guidance from the Countryside Council for Wales.

Consideration was given to the revised document, within which the initiatives proposed were grouped into three themes:

- Practical Improvements;
- Investigative Work;
- Negotiation and Management.

Each of the proposals would contribute significantly to improving coastal access and would demonstrate to be in accordance with the priorities given in

the Wales Coastal Access Improvement Programme. More local priorities, based on a Forum workshop session were considered more appropriate to carry forward into the full CIAP document.

The Forum endorsed the revised draft Outline Coastal Access Improvement Programme.

The Wales Coastal Access Improvement Programme guidance required the establishment of a partnership to progress the Vale of Glamorgan Coastal Access Improvement Programme. It had previously been suggested that a **Vale of Glamorgan Coastal Access Advisory Group** could be formed from a core of, perhaps, six Forum members, together with a representative from selected organisations, to provide a strategic advisory group and sounding board for coastal access issues. The suggested organisations were the Country Landowners and Business Association, the National Farmers Union, the Farmers Union of Wales, the Environment Agency, the Vale Marketing Group (representing tourism interests) and the Cardiff and Vale Coalition of Disabled People. Initial contact had already been made with most of these organisations.

In addition to the above, direct consultation would need to involve other sections within the Council, specific landowners, user groups and Community

Councils. It might be appropriate to have a wider partnership meeting on an annual basis to discuss issues and progress on the CIAP.

The Advisory Group will be facilitated in a similar way to the Local Access Forum, with its proceedings being reported on to the Forum and the Council's Scrutiny Committee (Economy and Environment) and / or Cabinet as appropriate. The following members of the Forum were nominated to serve on the Coastal Access Advisory Group:

Mrs. V.M. Hartrey, Mr. J.J. Herbert, Mrs. H. March, Mr. H.S. McMillan and Mr. R. Simpson.

The **Performance Indicator for Public Rights of Way** asked for the percentage of total lengths of rights of way which were easy to use by members of the public in order to measure trends and progress. Guidance currently recommended a survey of a minimum of 5% of the length of the network each year to achieve the desired result. The Forum agreed that a similar exercise to that undertaken in Autumn 2006 and Spring 2007 be carried out in the late Summer / Autumn 2007 with a view to completing a regular PI survey every year to supplement the Spring 5% return and to moving towards incorporation into Action 10 of the ROWIP which sought a 10% annual sample survey.

Finally, at the May meeting, the Chairman referred to the imminent retirement of Mr. Coleman and to his tireless work on behalf of the LAF. Members on the LAF joined the Chairman in wishing him a happy, healthy and long retirement.

September 2007

The Forum noted the resignation from the LAF of Mr. Williams and agreed that the Secretary convey the Forum's best wishes.

Members received a presentation from Mr. C. Heaps, Countryside Access Officer, CCW on the **Welsh National Access Register (WNAR)**. The WNAR was in essence CCW's website and had been a direct result of the CROW Act whereby an obligation had been placed upon CCW to publicise areas of access and areas where access was not permitted.

Phase 2 in the development of the site related to forming partnerships with local authorities and others and obtaining information. Details were then given on how to use the map guide. The maps contained very detailed information identifying, for example, promoted sites and Wildlife Trust areas. Agreements had been reached with most local authorities and the Vale of Glamorgan Council had signed up. The agreement meant that the Council shared information with CCW and that it was published by CCW. New walks and sites were continually being added and it was hoped that accommodation would also be added. in the near future.

The Countryside Council for Wales had invited comments on the document "**Route Criteria and Quality Standards for the Development of the Wales Coastal Path**" by the deadline of 16th November, 2007. CCW had invited responses to the following questions :

- Q1 Do you agree that the proposed Route Criteria (RC1 - RC4) should be adopted for the Wales Coastal Path?
- Q2 Do you think that there should be any additional criteria? If so, what should they be?
- Q3 Do you agree with the Alternative and Key Link Route information?
- Q4 Do you agree that the proposed standards (QS1 - QS8) should be adopted for the Wales Coastal Path?
- Q5 Do you think any additional standards should be added to this list? If so, what should they be?

An internal consultation exercise conducted within the Council had shown that the main issues of concern related to RC2, and to a lesser extent, RC3 - “the public should have a permanent right of access on foot” and “the route should be physically available at all times” respectively.

Given the particular situation along the Heritage Coast where erosion was a major issue, much of the coastal route had been made available through negotiations with local landowners and access was, therefore, permissive. Accordingly, whilst a permanent path was to be desired, the emphasis on permanence in the consultation paper was seen as overly prescriptive. To ensure a permanent coastal path along the Heritage Coast would necessitate a substantial amount of land being set aside to avoid frequent negotiations with landowners to move the path further inland, given the pace and scale of erosion in the area. Concerns were expressed that not only would the matter of compensation to those landowners for the loss of their land have to be addressed, but the current goodwill of those landowners in making land available would be lost. The threat of legislation, therefore, was seen as being counterproductive in an area where current arrangements to ensure coastal access worked well. Whilst reference was made to the desirability of having consistent criteria relating to coastal access for the whole of Wales, the general view was that the particular circumstances of the Heritage Coast needed to be recognised.

Discussion then ensued on the questions set out above specifically posed by CCW.

- Q1 Whilst the principle of there being a continuous walking route around the coast of Wales, physically available at all times, and as close to the sea as practicable and desirable was accepted, particular issues arose as indicated above in relation to the question of “permanence”.
- Q2 The question of permissive paths needed to be addressed.
- Q3 No adverse comments.
- Q4 One point raised touched upon the need for and practicalities of ensuring that all sections of the path were delivered to the highest quality standards (when, for example, certain sections would only be lightly trafficked). The second issue focussed on an omission in QS3 “Furniture”. Given the inherent risk of walking along a coastal path, it was considered that reference should be included in QS3 to some form of barriers or guardrails being installed in high risk areas. It was considered that to a large extent the criteria proposed under QS3 related more to furniture on country than coastal routes.
- Q5 As indicated in the response to Q4 above.

During the course of subsequent discussion reference was also made to vague phrases within the document such as “substantially in place” and “where appropriate” and how those should be interpreted. It was accepted

that the reference to temporary diversions referred to legal temporary diversions which had time elements built into them. Clarification was also requested as to the potential liability that would fall on officers and on the Council in the event of vandalism and damage along the coastal path resulting from, for example, the removal of signs and reduced access. Discussion then turned to coastal access in the Sully / Barry area, following which it was confirmed that further reports would be made to subsequent meetings of both the Coastal Access Advisory Group and the main Local Access Forum as the programme progressed.

An update on the **Coastal Access Improvement Programme (CAIP)** was submitted.

Members had been informed at the previous meeting that an optimistic total bid had been made for funding under the CAIP of £177k. An offer of grant of £146.8k. was subsequently received. That offer had been made on the basis of certain CCW amendments to the submitted programme of potential schemes, and the final approved list of schemes is summarised below :

The Forum also considered the Council's final draft **Rights of Way Improvement Plan (ROWIP)** prior to it being reported to the Council's Cabinet. A further two responses to the draft had been received from the Environment Agency Wales and Cadw, bringing the total number of responses to 23. The draft had been adjusted in response to those comments.

Matters raised which were accepted included the reference to RAF St. Athan being amended to read "MOD" and the inclusion of nPower Aberthaw. Discussion also ensued on the question of targets and the need to recognise somewhere in the document that, whilst the inclusion of specific targets might be desirable, the achievement of those targets would be largely dependent upon the necessary funding being made available. The Statement of Actions was recognised as ambitious and the view expressed that, given the uncertain funding situation, the inclusion of fixed targets could be seen as unhelpful.

Reference was also made to the format of the document itself which, whilst clearly laid out, had been produced in a smaller font size than the Council's corporate style. Attention was drawn, however, to the fact that the ROWIP would be made available on the Council's website where any issues relating to its legibility could be easily addressed by viewers.

In conclusion, the officers involved in the production of the ROWIP were congratulated on their work - the contribution of CCW also being acknowledged.

January 2008

The Chairman welcomed Mr. Bob Guy, the recently appointed Operational Manager for Countryside and Economic Projects.

The Chairman welcomed Irene Evison, Consultant from "Resources for Change", to the meeting. Ms. Evison briefly explained her role in the process and outlined the aim of the **Wales Coastal Access Programme**. The programme, funded by WAG and administered by CCW, was currently in its first year and the remainder of phase 1 (April '07 to March '10) would commence in the 2008/09 financial year.

She referred to the work undertaken by the Council's Rights of Way team and to the consultation undertaken. It was important to identify those actions/improvements the Council would like to see over the next three to five years and the views of the Local Access Forum were requested. The responses of the LAF, Council officers and the Glamorgan Heritage Coast Advisory Group

had been submitted and an analysis of the responses from all over Wales would be made available to the Council in due course.

Whilst overall priorities would be set for Wales in various respects, for example the percentage of routes available for riders/cyclists, serious consideration would be given to accommodating the views of this and other LAFs / consultees in maintaining and improving coastal access within their areas having regard to individual circumstances. The LAF had previously expressed strong views that, although a permanent path was to be desired, the emphasis on permanence in the consultation paper was seen as overly prescriptive.

Discussion then focused on the suggested action plan projects as shown below and maps tabled, the maps having been split into 8 sections with section 1 showing the most easterly section of the Vale and map 8 the most westerly :

Points raised in subsequent discussion included:

Map 1

A note added to the effect that, because of the non-continuance with the Penarth Headland Link Scheme, the proposed coastal path would be driven inshore.

Map 2

The need for the projects to be listed in sequential order along the coastline, it being noted that the order would be re-worked for insertion into the final action plan; and the suggestion made that the content of the information boards relating to Sully Island needed to give clear and precise information as to the potential dangers of accessing and egressing the Island.

Map 3

The question was asked as to why the rebuilding of the Golden Stair had been given a high priority and a request made that the priority be reduced.

Map 4

In response to questions, issues including the reassessment of paths at Aberthaw Power Station, the cliff steps at Aberthaw and the erosion at the Rhoose Point development were clarified. The suggestion was made that consideration could be given to improving disabled access on to a section of the path at Aberthaw Power Station.

Maps 5 and 6

Reference was made to a very heavily used route from the bottom of Colhuw Street to the beach and the strong local feeling that the route could be much improved. It was considered that the route could be made disabled user friendly and that it should be accorded high priority. It was recognised that the path in question was already included on the list as part of a proposed circular work, given a medium priority, but it was felt that this particular section should attract a higher priority.

It was also suggested that the bridleway that presently ran along Church Road to a dead end where it became a public footpath could be extended as a bridleway westwards or up to the main road thereby providing a much appreciated local facility.

Maps 7 and 8

The Council had yet to determine its stance in relation to the slipways mentioned given the question of ownership and the use of slipways for both the launching of waterborne craft and access onto the beach by walkers and disabled users. Given that the CAIP related specifically to pursuits such as walking and cycling, clarification was required as to whether CCW meant coastal access and / or access to the beach / foreshore and whether works to slipways would attract funding.

In response to questions, Irene Evison confirmed that with all the above proposals more detail would be given as the action plan was drawn up and refined.

It was accepted that the highest priority was to put the coastal path into place and noted that a lot of the actions contained within the above list related to missing links in the network. Other issues to be raised when discussing the action plan would include those projects which were not site specific such as

guided walks, working in partnership, way marking surveys, and staff costs. A particular point raised at the meeting was the use of the Sea Watch Centre at Summer House Point on a part time basis as a Coast Watch location although the security of the car parking facilities there would require addressing and the fact that it was accessed by a permissive path. Ms. Evison concluded her presentation by referring to the timetable whereby grant applications had to be submitted to CCW by mid-February with the CAIP being with CCW by the end of June 2008. Members of the LAF were invited to contact her and / or the Rights of Way Team with any further comments.

The **Chairman** announced that he was to relinquish his seat on the Council at 1st May, 2008 and that he could, therefore, no longer continue in the post of Chairman of the LAF. The process to be followed as a consequence in respect of electing a new Chairman was briefly outlined.

In response to a question relating to possible future funding difficulties for **Valeways** and the possible consequential impact on the ROWIP, Bob Guy confirmed that he would be meeting the Chief Officer of Valeways to discuss the situation. It was further explained that Valeways was a charity and obtained funding from a number of organisations but that, in the current financial climate, the likelihood was that there would be a funding gap with consequent implications for the current staffing levels and therefore the work able to be undertaken for the Vale.

At the conclusion of the meeting, the thanks of the Forum were conveyed to the Chairman for his leadership and guidance since the inception of the LAF.

The composition of a Local Access Forum is clearly crucial to its success. With this in mind, a careful recruitment and appointment exercise was undertaken by the “Appointing Authority” during 2002.

The Regulations require that, as far as practicable, the Local Access Forum should have a fair balance between persons of different genders, races, ages, disabilities and other characteristics. With this in mind, the “Appointing Authority’s” Equalities Officer was fully briefed on the appointment exercise undertaken and confirmed that all appropriate procedures were followed.

Applications for membership were sought through an advertisement in the Glamorgan Gem on 16th May 2002, with expressions of interest required by 14th June 2002. In addition, letters were sent to individual interest groups (as listed overleaf).

As a result of the above, 42 requests for information and/or application forms were received, with approximately 30 completed application forms subsequently received.

The appointment process was undertaken by a Selection Panel comprising the Secretary to the Forum, the Operational Manager (Countryside and Environmental Projects) and the Rights of Way Officer. In appointing members to the Forum, careful consideration was given to the following criteria:

- the desirability of appointing persons who reside in, or are otherwise particularly familiar with, or have other interests especially relevant to, the area of the Forum;
- that membership achieve a reasonable balance between the interests of users of local rights of way or the rights of access conferred by Section 21 of the Act and of owners and occupiers of access land or land over which local rights of way subsist;
- the need to ensure, so far as reasonably practicable, a fair balance between persons of different genders, races, ages, disabilities and other characteristics.

Following the initial three year term of office of the Forum, as required by legislation, a re-appointment exercise took place.

Recruitment Details (contd/...)

An advertisement was placed in the local press and on the Council's website inviting expressions of interest in becoming a member of the Forum.

29 requests for application forms were received, of which 20 were returned, including nine from existing members of the Forum. As occurred when the Forum was originally established, officers undertook a selection process, endorsed by the Council's Equalities Officer, designed to ensure that members were appointed and/or reappointed representing as wide a range of interests as possible in accordance with the guidance and regulations covering Local Access Forums.

Terms of Reference

1. The Local Access Forum shall be known as the Vale of Glamorgan Local Access Forum.

Roles and Responsibilities

2. The function of the Vale of Glamorgan Local Access Forum is to provide advice to the relevant local authorities, the Countryside Council for Wales (CCW) and others as appropriate as to the improvement of public access to land in the area for the purposes of open-air recreation and the enjoyment of the area in ways which take account of land management, social, economic, environmental and educational interests.
3. The Vale of Glamorgan Local Access Forum will fulfil this role by advising on issues of particular local relevance, including:
 - (a) supporting the implementation of the new right of access to open countryside;
 - (b) improving the rights of way network; and
 - (c) developing recreation and access strategies that cater for everyone.
4. The Vale of Glamorgan Local Access Forum will work to:
 - (a) develop a constructive and inclusive approach to the improvement of recreational access to the countryside;
 - (b) respect local circumstances and different interests whilst operating within national guidance;
 - (c) provide advice on issues of principle and good practice;
 - (d) engage in constructive debate and seek consensus wherever possible; and
 - (e) where consensus is not possible, make clear the nature of differing views, and suggest how they might be resolved.

Terms of Reference (contd/...)

Membership

5. The membership will include:
 - (a) a Chair and Deputy Chair elected in accordance with the LAF regulations;
 - (b) a minimum of 10 and a maximum of 20 other members, which must include a balanced representation of (i) recreational access users and (ii) landowners and occupiers – together with representation of other interests especially relevant to the area.

6. The membership will:
 - (a) be balanced to avoid dominance by any single interest group;
 - (b) represent a cross-section of interests in the area; and
 - (c) live or work within the area or have a sound knowledge of the area.

7. Members will be expected to:
 - (a) adhere to the sections relating to LAFs in the CROW Act and regulations and these Terms of Reference;
 - (b) show commitment to achieving the aims of the Local Access Forum through constructive working with other members;
 - (c) be able to devote the necessary time to attend meetings and to network outside meetings;
 - (d) have sufficient experience of access to the countryside in the local areas to be able to make an informed and constructive contribution to improving access provision; and
 - (e) be capable of working with a wide range of interest groups.

Administration

Secretariat

8. The Vale of Glamorgan Local Access Forum will have a Secretary appointed by the appointing authority who will be responsible for:
 - (a) providing support to the Chair of the Forum;
 - (b) ensuring that the Forum is set up and run according to the CROW Act, Local Access Forum regulations and these Terms of Reference;
 - (c) managing any resources dedicated to its work;
 - (d) arranging and promoting meetings, including arranging the delivery of papers and information to Forum members and the public;
 - (e) producing minutes of Forum meetings.

Terms of Reference (contd/...)

Meetings

9. Meetings will be held at least two times a year, and more frequently as and when necessary, to be agreed by the LAF and the appointing authority.
10. Meetings agendas will be agreed between the Chair, the Deputy Chair and the Secretary – although any member may suggest agenda items for consideration.
11. Meetings will be advertised in advance and the minutes published.
12. The Chair will invite observers/advisors to the meeting when appropriate.
13. Observers/advisors will be able to contribute to the proceedings at the discretion of the Chair.
14. One representative of each of the Countryside Council for Wales and the National Assembly for Wales and any officer of the appointing authority will automatically have observer status.
15. If necessary, Local Access Forum committees will be set up by the Chair after agreement with the members.
16. The chairing, membership and terms of reference of committees will be agreed by the Chair and members.
17. All meetings of the LAF will be held in public. However, the person presiding, following a request from a member or members, may decide that the public should be barred for particular items for reasons of personal privacy or commercial confidentiality.
18. Should a member of the Forum feel he/she might have conflict of interest relating to a specific agenda item, such interest should be declared.
