# **Report of the Monitoring Officer**

# **Code of Conduct Training Post 2017 Local Government Elections for Town and Community Councils**

## **Purpose of the Report**

1. To advise Members of the Committee of the training that is to be offered to all Members of Town and Community Councils and Clerks.

#### Reason for the Recommendation

To inform Members of the Standards Committee.

## **Background**

2. The Terms of Reference of the Standards Committee include (in part) "Promoting and maintaining high standards of conduct" and "advising, training or arranging to train Councillors, Co-Opted Members and church and parent governor representatives on matters relating to the Members' Code of Conduct".

## **Relevant Issues and Options**

- 3. Following the Local Government elections on 4th May, 2017, training on Code of Conduct matters was provided to newly elected Vale of Glamorgan Councillors on 16th and 18th May, 2017. A total of 44 Vale of Glamorgan Councillors attended the training sessions and the three remaining Members were invited to attend further sessions with the Monitoring Officer, which have also subsequently taken place.
- 4. At its meeting on 1st June, 2017, the Standards Committee was advised that training for Members of Town and Community Councils in the Vale of Glamorgan would be delivered by the organisation One Voice Wales, the Voice of Community and Town Councils in Wales, and the cost would be met by the Vale of Glamorgan Council.
- 5. Following confirmation with One Voice Wales, the training sessions have now been arranged as follows:

- Tuesday, 17th October, 2017 from 2.00 p.m. to 4.30 p.m.
- Thursday, 19th October, 2017 from 2.00 p.m. to 4.30 p.m.
- Tuesday, 24th October, 2017 from 6.30 p.m. to 9.00 p.m.
- Tuesday, 6th November, 2017 from 6.30 p.m. to 9.00 p.m.
- Tuesday, 14th November, 2017 from 6.30 p.m. to 9.00 p.m.
- 6. All Town and Community Councils' Members and Clerks have been invited to attend the sessions and responses are being received and collated.
- 7. Following the training sessions a feedback report will be presented to the Standards Committee for consideration.
