# Access to Information for Children & Families



## **Introduction**

We all have a general right to access information that is held about us.

## **Your right of access to information**

The Data Protection Act 1998 gives you the right to see what information we have about you.

Information may be in a paper file or on a computer.

## **Keeping information confidential**

We are committed to keeping information confidential. We would not share your information with anyone else without your permission. We cannot share information on your file with you that has been given to us by other people in confidence, without their agreement.

There are a few other situations in which we could not show certain parts of the file to you, such as when someone might suffer serious harm as a result.

Information about you will not be passed on to anyone else unless they need it to do their job and only with your permission, if that is practical. For example, other people who work with you, such as a carer or nurse will need to know something about your needs so that they can care for you properly.

Apart from this sharing of routine information which you will already know about, we will not pass on any information about you to anyone without your permission except in specific circumstances such as when we are required to do so by Law.

## **Formal requests for information**

If you make a request in writing to see information we have about you we have a duty to provide this to you within 40 days. Sometimes this may take longer and we will explain why to you.

One of the things we will do during the 40 days is ask people who have given us information in confidence their view as to whether that information should be given to you.

## **Children**

Children have a right to see information we hold concerning them. If a child is old enough to understand the information then we cannot let a parent see it unless the child gives permission.

## **Right to change the information**

If you can show that any of the information we hold is incorrect then we must put it right. If you consider that it is incorrect but we cannot reach an agreement on what it should say then your comments on the information will be added.

## **Appeals and complaints**

If you disagree with any decision we have made then you can use the complaints procedure, details of which are in the leaflet "How to make a Complaint about our Services" available from any Social Services Office.

## **Charges**

You are entitled to a copy of the information about you. For processing requests there will be a maximum charge of £10.

Rydym wedi ymrwymo i gadw gwybodaeth yn gyfrinachol. Ni fyddem yn rhannu eich gwybodaeth chi gydag unrhyw un arall heb ofyn am eich caniatâd yn gyntaf. Ni allwn rannu gwybodaeth gyda chi sydd yn eich ffeil ac a roddwyd i ni gan bobl arall yn gyfrinachol, heb gael eu cytundeb nhw yn gyntaf.

Mae rhai sefyllfaoedd eraill yn bodoli lle na fyddai modd i ni ddangos rhannau penodol o'r ffeil i chi, megis pan allai rywun ddioddef niwed difrifol o ganlyniad.

Ni throsglwyddir gwybodaeth amdanoch chi i unrhyw un arall oni bai bod ei hangen arnynt i gyflawni eu swydd a dim ond ar ôl sicrhau eich caniatâd chi, os yw hynny'n ymarferol. Er enghraifft, bydd angen i bobl arall sy'n gweithio gyda chi, fel gofalwr neu nyrs, wybod rhywbeth am eich anghenion er mwyn iddynt allu gofalu amdanoch yn gywir.

Ac eithrio rhannu'r wybodaeth hon, y byddwn yn gwybod amdani yn barod, ni fyddwn yn trosglwyddo unrhyw wybodaeth amdanoch i unrhyw un heb eich caniatâd, oni bai mewn amgylchiadau penodol fel y rhai pan fydd yn rhaid i ni wneud hynny yn ôl y Gyfraith.

## **Ceisiadau ffurfiol am wybodaeth**

Os byddwch yn gwneud cais ysgrifenedig i weld gwybodaeth sydd gennym amdanoch, mae gennym ddyletswydd i ddarparu'r wybodaeth hon i chi cyn pen 40 diwrnod. Weithiau, bydd yn cymryd mwy o amser a byddwn yn esbonio'r rheswm pam i chi.

Un o'r pethau y byddwn yn ei wneud yn ystod y 40 diwrnod yw gofyn i bobl sydd wedi rhoi gwybodaeth i ni yn gyfrinachol, am eu barn ynghylch a ddylid rhoi'r wybodaeth honno i chi.

## **Plant**

Mae gan blant yr hawl i weld gwybodaeth sydd gennym amdanynt. Os bydd plentyn yn ddigon hen i ddeall y wybodaeth, ni allwn ganiatáu bod rhiant yn ei weld oni bai bod y plentyn yn rhoi eu caniatâd.

## **Yr hawl i newid y wybodaeth**

Os byddwch yn gallu dangos bod unrhyw ran o'r wybodaeth a gadwn yn anghywir, rhaid i ni ei chywiro. Os ydych o'r farn ei bod yn anghywir, ond os na allwn ddod i gytundeb ynghylch yr hyn y dylai ei nodi, ychwanegir eich sylwadau am y wybodaeth.

## **Apeliadau a chwynion**

Os na fyddwch yn cytuno ag unrhyw benderfyniad a wnaethpwyd gennym, gallwch ddefnyddio'r weithdrefn gwyno, a nodir manylion y weithdrefn hon yn y daflen "Sut i Gwyno" sydd ar gael gan unrhyw Swyddfa Gwasanaethau Cymdeithasol.

## **Taliadau**

Gallwch gael copi o'r wybodaeth amdanoch. Codir uchafswm o £10 am brosesu ceisiadau.
