### NOTES

1. Return the completed application form and appropriate fee together with your vehicle insurance certificate, vehicle registration document and current M.O.T certificate to the Licensing Department, Civic Offices, Holton Road, Barry. CF63 4RU.
2. You may telephone the Council's garage to arrange for the vehicle to be inspected (Tel : 029 20673243). The **vehicle is not licensed** to operate until it has **PASSED** inspection and a licence has been **ISSUED**.
3. If the vehicle inspection is satisfactory you are required to produce the pass certificate from the Council's Garage at the Licensing Department, Civic Offices, Holton Road, Barry, for confirmation.
4. The vehicle plate must be returned when the licence expires or is suspended or revoked. In the event of the application being refused owing to the unsuitability of the vehicle, only the vehicle plate deposit will be refunded.
5. The form must be returned to the Director of Legal and Regulatory Services, Civic Offices, Holton Road, Barry CF63 4RU. All cheques should be made payable to the Vale of Glamorgan Council.

#### Private Hire

In the case of an application for the Private Hire Vehicle Licence, you will also need a Private Hire Vehicle's Operator's Licence if you wish to conduct your own business. You need not apply for such a licence if it is your intention to work for a Private Hire firm which already holds a current Operator Licence issued by this Authority.
