

ANIMAL BOARDING ESTABLISHMENTS ACT 1963

What is the aim of the act?

- that animals will at all times be kept in accommodation suitable as respects construction, size of quarters, number of occupants, exercising facilities, temperature, lighting, ventilation and cleanliness;
- that animals will be adequately supplied with suitable food, drink and bedding material, adequately exercised, and (so far as necessary) visited at suitable intervals;
- that all reasonable precautions will be taken to prevent and control the spread among animals of infectious or contagious diseases, including the provision of adequate isolation facilities;
- that appropriate steps will be taken for the protection of the animals in case of fire or other emergency.

ANIMAL BOARDING ESTABLISHMENTS

All establishments in the business of providing boarding should be licensed



Persons who wish to carry on the business of providing accommodation for dogs and/or cats on behalf of their owners, must obtain a licence from the Council. A licence is required even if the premises concerned are a private dwelling.

Ask to see the kennels, see for yourself where your animal is staying.

A list of licensed premises is available from the Vale of Glamorgan Council on request.

THINGS TO CONSIDER

Example questions to ask...

- Can I see the kennels?
- How often do you visit the animals?
- Are there any surcharges (e.g. heating, insurance, food...)?
- How do you maintain a consistent climate within the kennels?
- How do you decide whether an animal needs heating or not?
- How often do you check water bowls?
- Which vaccinations do you insist on?
- Are you approved by any UK recognised animal societies?
- What would you do in case of illness?
- What precautions do you make against injury?
- What precautions do you make against disease?

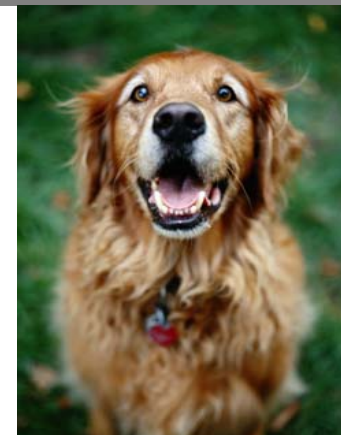
