

I AVERIL HAROLD DO SOLEMNLY AND SINCERELY DECLARE as follows:



The Woodland Trust, a company limited by guarantee and registered charity no. 294344, is and has been since 17 December 1997 the owner of the land known as Casehill Wood, Dinas Powys more particularly delineated as the unhatched area on the plan accompanying this declaration and thereon edged red.
2. On the 9 May 2002 the Woodland Trust deposited with Vale of Glamorgan Council, being the appropriate Council, a statement accompanied by a plan delineating our property by red edging which stated that:
  - no ways had been dedicated as highways over our property.
3. No additional ways have been dedicated over the land edged red on the plan accompanying this declaration since the statement dated 9 May 2002 referred to in 2 above and at the present time the Woodland Trust has no intention of dedicating any more public rights of way over its property.






The ways coloured purple on the said plan have been dedicated as footpaths.
