






STATUTORY DECLARATION

SECTION 31 (6) OF THE HIGHWAYS ACT 1980

1. We are and have been since the 11th May 1994, the Trustees of the legal Estate in and owners of the land known as The Windmills, Field GR6200 in the Parish of Llanblethian, more particularly delineated on the plan accompanying this declaration and thereon edged red.
