

4. Ways coloured red on the said map are restricted byways.


5. Ways coloured green on the said map are public bridleways.

6. Ways coloured purple on the said map are public footpaths (Nos 1, 2, 3 as shown).


7. No other ways over the land have been dedicated as highways.

STATUTORY DECLARATION

SECTION 31(6) OF THE HIGHWAYS ACT 1980

I [name] DO SOLEMNLY AND SINCERELY DECLARE as follows:

1. I, [REDACTED] am and have been since 29th day of May 1987 the owner of the land known as Fonmon Castle Estate, part of which is more particularly delineated on the map accompanying this declaration and thereon edged red.
2. On the 24th day of March 2015 I deposited with Vale of Glamorgan Council, being the appropriate Council, a statement accompanied by a map delineating my property by red edging which stated that the ways coloured purple on the said map and on the map accompanying this declaration had been dedicated as footpaths. No ways had been dedicated as highways over this part of my property.
3. No additional ways have been dedicated over the land edged red on the map accompanying this declaration since the statement dated 24th March 2015 referred to in (2) above footpaths marked in the appropriate colour on the map accompanying this declaration and at the present time I have no intention of dedicating any more public rights of way over my property.
