Context of this objective

Key to achieving the vision of the Learning and Skills Directorate, 'Achievement for All,' is to secure the best possible learning environment through designing and developing school buildings fit for the 21st Century. This accords with the Welsh Government's 21st Century Schools Programme, which was launched in March 2010 to support large-scale capital building projects across Wales with the aim of enhancing school buildings to meet 21st century educational needs.

The Council has set out a new £74.73 million Vale of Glamorgan School Investment Programme (SIP) for the period 2012/13 to 2019/20. The SIP includes £47.16 million earmarked to facilitate the construction of Penarth Learning Community an ambitious project, which will deliver a new state of the art secondary school replacing St Cyres Comprehensive School and a new regional Special Education Needs School. This will be followed by further proposed investments which total £20.96 million including remodelling Llantwit Major Comprehensive School and transforming and enhancing various primary schools in Llantwit Major and Barry by 2020, along with £6.61 million intended for annual Asset Renewal works across the wider school estate.

Outcome (3):	Learning environments are stimulating, safe, healthy, secure and efficient	
Objective (12):	To ensure that learning provision meets changing educational needs	

Context for this objective

Learning provision should equip young people with the skills and knowledge they need to gain meaningful employment, long term economic stability and lead a fulfilling life in the broadest sense. In the Vale of Glamorgan, this is achieved by developing local solutions to meet local needs through networks of education providers, partners and the council working together in the best interests of young people.

Local and regional approaches are taken in order to effectively address the key strategic issues affecting education and skills of young people enabling them to:

- develop the skills and knowledge they need to progress into employment or higher education;
- meet the needs of employers and become a valued employee;
- make a positive contribution to society; and
- live healthy, independent lives.

It is important that funding for education is used effectively to achieve this. Some spare places are necessary to enable schools to cope with fluctuations in numbers of pupils, but excessive numbers of places mean that resources are tied up unproductively. The Welsh Government recommends that councils review their provision and, where feasible, make proposals for school reorganisation especially where schools have significant surplus places, require significant investment or have a catchment area which is unlikely to provide a sufficient number of pupils to make it sustainable in the future.

In the School Organisation Guidance issued in September 2009 WG recommends that local authorities should aim to retain no more than 10% surplus places overall although levels at individual schools may be higher than this particularly in rural areas. Currently, there is an overall surplus of 14.74% in the primary sector and 9.28% in the secondary sector, although this masks schools with significantly higher surplus capacity. There are currently 8 primary schools and 1 secondary school with significant surplus capacity (in excess of 25%). As

part of the Inspection of Local Authority Education Services for Children and Young People, Estyn will make a judgement in relation to Access and School Places. Good provision is defined as:

'Overall there is enough capacity in all kinds of schools and very few schools are significantly over filled or have significant surplus capacity. Priorities for investment in the Asset Management and Capital Programme are clear, funded and agreed and based on up-to-date information. The quality of school buildings and other settings is generally good.'

Work is underway to review the capacity of a number of schools with a view to reducing surplus capacity through assigning space to other uses or removing accommodation wherever possible, e.g. demountable accommodation.

The School Investment Programme has been identified as a corporate risk due to the risks associated with securing the necessary capital required to fund major investment projects as well as addressing building conditions across all Vale schools. A reduction in 21st Century Schools Grant funding and general capital funding could result in buildings deteriorating further giving rise to risks associated with health and safety, DDA, business continuity and sustainability. The need to accommodate a rapid increase in demand for welsh medium primary sector education has also required investment. Failure to address a shortage of places in this sector will impact on the Vale's ability to secure WG 21st Century Schools Grant in the future. Actions taken to mitigate risk include the development of a new School Investment Programme which clearly sets of investment priorities and funding sources. This will be reviewed annually in tandem with the development of the rolling Capital Programme. A 25 year rolling asset renewal programme has been developed to ensure limited capital funding is targeted to schemes which are deemed a Health and Safety priority. Significant work has been carried out with Members to review school places and investment needs.
