

## **Free Prize Draw Terms and Conditions**

1. By entering the prize draw you are agreeing to these prize draw terms and conditions.
2. The prize draw is being run by Electoral Registration Department, Vale of Glamorgan Council. Holton Road, Barry, CF63 4RU.

### **Eligibility to enter**

3. The prize draw is open to entrants who are qualifying foreign nationals who have permission to live in Wales and/or entrants between the ages of 14 -21 years of age. Only a successful application to register to vote on the Electoral Register will be eligible.
4. Entrants under 18 must have the consent of a parent or guardian over 18 to enter the competition. The Vale of Glamorgan Electoral Registration department reserves the right to obtain proof of such consent and to refuse entry or to choose another winner if such proof, where requested, has not been given.
5. In entering the prize draw, you confirm that you are eligible to do so and eligible to claim any prize you may win.
6. A maximum of one entry per individual is permitted.
7. The prize draw is free to enter.

### **How to enter**

8. The prize draw will include those who have already had a successful application to add their name to the Electoral Register from 1<sup>st</sup> December 2021 which is the date that the updated Electoral Register was last published.
9. The closing date of entry is 14<sup>th</sup> April 2022. This is also the deadline date that the Electoral Registration Department will need to receive an application to register in time for the Local Election. Entries after that time and date will not be included in this prize draw.
10. Applications to be added to the Electoral Register received after the closing date will be processed but will not be eligible for this prize draw.
11. Vale of Glamorgan Council will not accept responsibility if contact details provided are incomplete or inaccurate.

### **The prize**

12. The prize will be one of five Apple iPads 2020 32GB, Gold in colour.
13. Vale of Glamorgan Council use of particular brands as prizes does not imply any affiliation with or endorsement of such brands.
14. The winner will be drawn at random.

15. The prize is non-exchangeable, non-transferable and no cash alternatives will be offered.

15. We reserve the right to substitute prizes with another prize of equal or higher value if circumstances beyond our control make it necessary to do so.

17. The decision of Vale of Glamorgan Council regarding any aspect of the prize draw is final and binding and no correspondence will be entered into about it.

### **Winner announcement**

18. The winner will be notified after 31<sup>st</sup> May 2022 via the contact details provided during the application process.

19. Vale of Glamorgan Council will attempt to contact the winner by email up to two times and by telephone up to three times.

20. If the winner does not respond to the emails notifying them of their win within 14 days of the second email, they will lose their right to the prize, and the Vale of Glamorgan Council reserves the right to choose and notify a new winner.

21. Arrangements will be made between Electoral Registration Department and the winner's parent, guardian or teacher on a suitable time and place the young person can receive the prize. This will depend on any government Covid restrictions that are in place at the time of collecting the prize.

22. Should the Vale of Glamorgan be in a 'lockdown' situation at the time of presentation, arrangements will be made to collect the prize at a time that is Covid safe and lockdown has been lifted.

23. Prizes can be presented to the prize winner on school grounds if the school is happy to be involved with the prize giving under Covid restrictions.

24. Electoral Registration reserve the right to photograph the presentation. Any photographs taken can be used to publicise the event and can be used to help encourage voter registration in the Vale of Glamorgan authority.

### **Receipt of the prize**

25. Please allow 14 days for delivery of the prize or alternative collection or delivery arrangements may be made through mutual agreement.

### **Data protection and publicity**

26. You consent to any personal information you provide in entering the prize draw being used by Electoral Registration for the purposes of administering the prize draw, and for those purposes as defined within your application and our privacy notice.
