Proposed Prohibition of Waiting At Any Time

Cliff Parade, Penarth - Map Schedule AN65

On the south west side from a point 6 metres north west of the main western flank wall of the public conveniences, in a south easterly direction for a distance of 56 metres to run contiguous with existing.

SCHEDULE 2

Proposed Prohibition of Overnight Parking and Stopping of Motor Caravans and Campervans - 11pm until 7am 7 Days a Week

Proposed Prohibition of Overnight Parking and Stopping of Goods Vehicles exceeding 3.5 Tonnes - 11pm until 7am 7 Days a Week
