

**THE VALE OF GLAMORGAN COUNCIL  
(PROHIBITION AND RESTRICTION OF WAITING AND  
LOADING AND PARKING PLACES)**

**(CIVIL ENFORCEMENT) (AMENDMENT) (NO 6) ORDER 2020**

1. On the 21<sup>st</sup> July 2020 The Vale of Glamorgan Council in exercise of its powers under the Road Traffic Regulation Act 1984 and the Traffic Management Act 2004 and all other enabling powers made an Order to install and remove the parking restrictions specified in the schedules below.
2. The Order will come into operation on 27<sup>th</sup> July 2020 or on the dates that the signs and road markings are removed or installed whichever is the later and be known as the "Vale of Glamorgan Council (Prohibition and Restriction of Waiting and Loading and Parking Places) (Civil Enforcement) (Amendment) (No 6) Order 2020"

4. If you wish to question the validity of the Order or any provisions contained therein on the grounds that they are not within the powers conferred by the above Act or on the grounds that any requirement of the same or that any instrument made under it has not been complied with in relation to the Order, you may within six weeks from the 27<sup>th</sup> July 2020 apply to the High Court for this purpose.

The following Traffic Regulation Order is to be amended as follows:

**Vale of Glamorgan Council (Prohibition and Restriction of Waiting and Loading and Parking Places) (Civil Enforcement) Order 2013**

**SCHEDULE 1**

**Proposed Prohibition of Waiting At Any Time**

**Murch Road, Dinas Powys - Map Schedule AM61**

On the east side from a point approximately 1.5 metres south of the southern building line of property number 53 in a generally southerly direction for a distance of approximately 116 metres.

On the west side from a point approximately 27 metres east of the junction with Cherry Close, in a generally southerly direction for a distance of approximately 37 metres.

On the west side from the northern side of the junction with the access road to Dinas Powys Health Centre, in a northerly direction for a distance of approximately 18 metres.

On the west side from the southern side of the junction with the access road to Dinas Powys Health Centre, in a generally southerly direction for a distance approximately of 31.5 metres.

On the south side from the junction with Ffordd Merrett in an easterly then south easterly direction for a distance of approximately 21 metres.

**Ffordd Merrett, Dinas Powys**

On both sides from the junction with Murch Road, in a south westerly direction for a distance of approximately 17 metres.

**SCHEDULE 2**

**Proposed Revocation of Prohibition of Waiting At Any Time**

**Murch Road, Dinas Powys - Map Schedule AM61**

On the east side from the southern boundary line of property number 53 in a southerly direction for a distance of 35 metres.

On the west side from the southern boundary line of property number 53 in a southerly direction for a distance of 121 metres.

On the south east side from the entrance to St Cyres Comprehensive School site (now Ffordd Merrett) in a north easterly direction for a distance of 35.1 metres.
