## **Proposed Prohibition of Waiting At Any Time**

### Beach Road, Southerndown - Map AD6, AE6 and AF6

On the east side from the junction with the B4524, in a southerly direction for a distance of 387 metres.

On the east and north east side from a point 406 metres south of the junction with the B4524, in a generally south easterly direction for a distance of 432 metres to run contiguous with existing. On the west side from the junction with the B4524, in a southerly direction for a distance of 24 metres.

On the west side from a point 35.5 metres south of the junction with the B4524, in a southerly direction for a distance of 36 metres.

On the west side from a point 100.5 metres south of the junction with the B4524, in a southerly direction for a distance of 44 metres.

On the west side from a point 154.5 metres south of the junction with the B4524, in a southerly direction for a distance of 9 metres.

On the west side from a point 187.5 metres south of the junction with the B4524, in a southerly direction for a distance of 16 metres.

On the west side from a point 214.5 metres south of the junction with the B4524, in a southerly direction for a distance of 10 metres.

On the west side from a point 232.5 metres south of the junction with the B4524, in a southerly direction for a distance of 112 metres.

On the south west side from a point 359.5 metres south of the junction with the B4524, in a south easterly direction for a distance of 471 metres to run contiguous with existing.

# Croft Lane, Southerndown - Map AD6, AE6 and AF6

On both sides from the junction with Beach Road, in a westerly direction for a distance of 7 metres.
