

**THE VALE OF GLAMORGAN COUNCIL
(EGLWYS BREWYS PUBLIC FOOTPATH No 1)
(TEMPORARY CLOSURE) ORDER 2020**

The Vale of Glamorgan Council in exercise of its powers under Section 14 of the Road Traffic Regulation Act 1984 and of all other enabling powers intends in not less than seven days from the date of this Notice to make an Order the general effect of which is as described in the schedules below: -

SCHEDULE 1

1. No person shall proceed on foot in the location specified in Schedule 2 below.

<u>Location</u>	Footpath (Public Rights of Way) known as Eglwys Brewys Number 1 closed from the point it meets the Cowbridge Road
<u>Alt. Route</u>	During this closure a signed diversion via Flemingston Road will be available
<u>Reason</u>	To prevent danger to the Public as a result of highway construction works Being carried out.
