**THE VALE OF GLAMORGAN COUNCIL
(LLANTWIT MAJOR PUBLIC FOOTPATH No 7)
(TEMPORARY CLOSURE) ORDER 2020**

On the 30th July 2020 the Vale of Glamorgan Council in exercise of its powers under Section 14 of the Road Traffic Regulation Act 1984, with the consent of Welsh Ministers made a further Order as described in the schedules below:

The Order shall come into force on 10th August 2020 and will be known as "The Vale of Glamorgan Council Llantwit Major Public Footpath No 7 (Temporary Closure) Order 2020.

If you wish to question the validity of the Order or any provisions contained therein on the grounds that they are not within the powers conferred by the above Act or on the grounds that any requirement of the same or that any instrument made under it has not been complied with in relation to the Order, you may within six weeks from the 10th August 2020 apply to the High Court for this purpose
