

**THE VALE OF GLAMORGAN COUNCIL  
(PROHIBITION AND RESTRICTION OF WAITING AND  
LOADING AND PARKING PLACES)**

**(CIVIL ENFORCEMENT) (AMENDMENT) (NO 3) ORDER 2021**

1. On the 5<sup>th</sup> July 2021 The Vale of Glamorgan Council in exercise of its powers under the Road Traffic Regulation Act 1984 and the Traffic Management Act 2004 and all other enabling powers made an Order to install the parking restriction specified in the schedule below.
2. The Order will come into operation on **19<sup>th</sup> July 2021** or on the dates that the signs and road markings are installed whichever is the later and shall be known as the “Vale of Glamorgan Council (Prohibition and Restriction of Waiting and Loading and Parking Places) (Civil Enforcement) (Amendment) (No 3) Order 2021”

4. If you wish to question the validity of the Order or any provisions contained therein on the grounds that they are not within the powers conferred by the above Act or on the grounds that any requirement of the same or that any instrument made under it has not been complied with in relation to the Order, you may within six weeks from the 19<sup>th</sup> July 2021 apply to the High Court for this purpose.

The following Traffic Regulation Order is to be amended as follows:

**SCHEDULE 1**

**Proposed Resident Only Permit Parking Areas, Cosmeston, Penarth**

**Amend the Resident Permit Areas contained within Schedule 1 of The Vale of Glamorgan Council (Prohibition and Restriction of Waiting and Loading and Parking Places) (Civil Enforcement) Order 2013, to include the following locations outlined within Cosmeston and Cowbridge, together with the removal of the footnote in Schedule 1, to include Refer to the “Resident Parking Permit Types and Criteria For Use”, within paragraph 4 of the Vale of Glamorgan Council Resident Parking Controls Policy.**

**Zone: PHZ01**

**Althorp Drive:** from its junction with Cosmeston Drive, throughout its entire length.

**Bittern Way:** from its junction with Cosmeston Drive, throughout its entire length.

**Cosmeston Drive:** from its junction with Lavernock Road, throughout its entire length.

**Falcon Grove:** from its junction with Cosmeston Drive, throughout its entire length.

**Fulmar Close:** from its junction with Cosmeston Drive, throughout its entire length.

**Kestrel Way:** from its junction with Althorp Drive, throughout its entire length.

**Lapwing Close:** from its junction with Althorp Drive, throughout its entire length.

**Mallard Way:** from its junction with Althorp Drive, throughout its entire length.

**Merlin Close:** from its junction with Althorp Drive, throughout its entire length.

**Osprey Close:** from its junction with Cosmeston Drive, throughout its entire length.

**Petrel Close:** from its junction with Bittern Way, throughout its entire length.

**Plover Way:** from its junction with Bittern Way, throughout its entire length.

**Raven Way:** from its junction with Cosmeston Drive, throughout its entire length.

**Shearwater Close:** from its junction with Cosmeston Drive, throughout its entire length.

**Zone: PHZ02**

**Upper Cosmeston Farm:** from its junction with Lavernock Road, throughout its entire length

**Proposed Resident Permit Parking Areas, Cowbridge**

**Zone: CBZ01**

**Middlegate Court:** from its junction with Town Hall Square throughout its entire length.

**Middlegate Walk:** from its junction with Middlegate Court, throughout its entire length.
