

**THE VALE OF GLAMORGAN COUNCIL  
(PROHIBITION AND RESTRICTION OF WAITING AND  
LOADING AND PARKING PLACES)**

**(CIVIL ENFORCEMENT) (AMENDMENT) (NO 11) ORDER 2021**

1. Notice is given that the Vale of Glamorgan Council in exercise of its powers under the Road Traffic Regulation Act 1984 and the Traffic Management Act 2004 and of all other enabling powers proposes to make an Order to install parking restrictions specified in the Schedule below.
2. Full details of the proposals, to include a copy of the proposed Order, and Plan No T/20/76/MS may be inspected on the Council's website at [www.valeofglamorgan.gov.uk](http://www.valeofglamorgan.gov.uk) and any objections you may have to this proposal must be submitted to the Director of Environment & Housing (Ref.IF929) in writing or by email to [C1V@valeofglamorgan.gov.uk](mailto:C1V@valeofglamorgan.gov.uk) by **Friday 24<sup>th</sup> December 2021** and must contain the grounds upon which you object.
3. Persons objecting to the proposed Order are advised that in view of the Local Government (Access to Information) Act 1985 this Council is legally obliged to make any comments received in response to the proposed Order open to public inspection.

The following Traffic Regulation Order is to be amended as follows:

**Prohibition and Restriction of Waiting and Loading and Parking Places (Civil Enforcement) Order 2013**

**SCHEDULE**

**Insert into Map Schedules AR31 and AS31**

**The following restrictions shall NOT apply, where the markings have been omitted at a gated access, a vehicular or pedestrian crossover, on any of the named roads.**

**Proposed Prohibition of Waiting at Any Time Order**

**St Athan Road, St Athan**

On the northern side, from its roundabout junction with Cowbridge Road, Eglwys Brewis Road and Ffordd y Spitfire, westwards for a distance of approximately 75 metres.

On the southern side, from its roundabout junction with Cowbridge Road, Eglwys Brewis Road and Ffordd y Spitfire, westwards for a distance of approximately 80 metres.

**Eglwys Brewis Road St Athan**

On the north-western side, from its roundabout junction with Cowbridge Road, St Athan Road and Ffordd y Spitfire, south-westwards for a distance of approximately 38 metres.

On the south-eastern side, from its roundabout junction with Cowbridge Road, St Athan Road and Ffordd y Spitfire, south-westwards for a distance of approximately 46 metres.

**Cowbridge Road, St Athan**

On the northern side, from its roundabout junction with Eglwys Brewis Road, Ffordd y Spitfire and St Athan Road, in a generally south-easterly direction to its junction with Cae'r Victor, a distance of approximately 215 metres.

On the northern side, from its junction with Cae'r Victor, in a generally south-easterly direction to its junction with Flemingston Road, a distance of approximately 90 metres.

On the southern side, from its roundabout junction with Eglwys Brewis Road, Ffordd y Spitfire and St Athan Road, in a generally south-easterly direction, contiguous with the existing prohibition of waiting at any time restriction, a distance of approximately 365 metres.

**Ffordd y Spitfire, St Athan**

On the western side, from its roundabout junction with Cowbridge Road, Eglwys Brewis Road and St Athan Road, northwards for a distance of approximately 25 metres.

On the eastern side, from its roundabout junction with Cowbridge Road, Eglwys Brewis Road and St Athan Road, northwards for a distance of approximately 27 metres.

**Cae'r Victor, St Athan**

On the north-western side, from its junction with Cowbridge Road, in a generally northeasterly direction for a distance of approximately 38 metres.

On the south-eastern side, from its junction with Cowbridge Road, in a generally northeasterly direction for a distance of approximately 17 metres.

**Flemingston Road, St Athan**

On the north-western side, from its junction with Cowbridge Road, north-eastwards for a distance of approximately 20 metres.

On the south-eastern side, from its junction with Cowbridge Road and contiguous with the existing prohibition of waiting at any time restriction, north-eastwards for a distance of approximately 15 metres.
