

**NOTICE OF MAKING OF AN ORDER**

**PUBLIC PATH DIVERSION ORDER 2021**

The above Order, made on the 24<sup>th</sup> September 2021, under Section 119 of the Highways Act 1980, will divert the public footpath running from a point to the east of Field Cottage, Bonvilston NGR 306309 173962 southwards crossing a field to terminate at NGR 306323 173825 to a line running from a point to the east of Field Cottage, Bonvilston NGR 306309 173962 southwards following the field boundary to terminate at NGR 306323 173825 as shown on the Order map.

If no such representations or objections are duly made, or if any so made are withdrawn, the Vale of Glamorgan Council may confirm the Order as an unopposed order. If the Order is sent to the Welsh Ministers for confirmation any representations and objections which have not been withdrawn will be sent with the Order.
