THE VALE OF GLAMORGAN COUNCIL (PROHIBITION AND RESTRICTION OF WAITING AND LOADING AND PARKING PLACES)

(CIVIL ENFORCEMENT) (AMENDMENT) (NO 5) ORDER 2019

- 1. On the 16th March 2021 The Vale of Glamorgan Council in exercise of its powers under the Road Traffic Regulation Act 1984 and the Traffic Management Act 2004 and all other enabling powers made an Order to install and remove the parking restrictions specified in the schedules below.
- 2. The Order will come into operation on 22nd March 2021 or on the dates that the signs and road markings are removed or installed whichever is the later and be known as the "Vale of Glamorgan Council (Prohibition and Restriction of Waiting and Loading and Parking Places) (Civil Enforcement) (Amendment) (No 5) Order 2019"
- 3. A copy of the Order and plans showing the affected area may be inspected on the Council's website at www.valeofglamorgan.gov.uk
- 4. If you wish to question the validity of the Order or any provisions contained therein on the grounds that they are not within the powers conferred by the above Act or on the grounds that any requirement of the same or that any instrument made under it has not been complied with in relation to the Order, you may within six weeks from the 22nd March 2021 apply to the High Court for this purpose.

The following Traffic Regulation Order is to be amended as follows:

Vale of Glamorgan Council (Prohibition and Restriction of Waiting and Loading and Parking Places) (Civil Enforcement) Order 2013

SCHEDULE 1

Proposed Prohibition of Waiting / Loading / Unloading at Any Time. Hood Road, Barry (Goodsheds Section)

On the west side from its junction with Ffordd-Y-Mileniwm for a distance of approximately160 metres in a northerly and then in a general south-westerly direction.

On the south east side from a point 165 metres from its junction with Ffordd –Y-Mileniwm for a distance of approximately 25.5 metres in a south westerly direction. On the southeast side from a point 235 metres from its junction with Ffordd-Y-Mileniwm for a distance of approximately 64 metres in a south-westerly direction. On the southeast side from a point 311 metres from its junction with Ffordd-Y-Milenium for a distance of approximately 51.5 metres in a south westerly direction. On the northwest side fronting the southern side of the health centre and contiguous with existing restrictions from a point 26.5 metres north-east of its junction with Island Road for a distance of approximately 23.5 metres in a north-easterly direction. On the northwest side fronting the southern side of the health centre from a point 80 metres north-east of its junction with Island Road for a distance of approximately 118 metres in a generally north-easterly direction.

On the northwest side fronting the southern side of the Pumphouse from a point 204 metres north-east of its junction with Island Road for a distance of approximately 49 metres in a generally north-easterly direction.

On the west side, fronting the eastern side of the Pumphouse, from a point 86 metres from its junction with Ffordd-y-Mileniwm, for a distance of approximately 10 metres in a northerly direction.

On the west side, fronting the eastern side of the Pumphouse, from a point 152.5 metres from its junction with Ffordd-y-Mileniwm, for a distance of approximately 25 metres in a northerly and westerly direction to its junction with the Pumphouse carpark.

On the east side from its junction with Ffordd-Y-Mileniwm for a distance of approximately 170.5 metres in a general northerly direction to its junction with the Premier Inn Hotel carpark.

Hood Road, Barry (Northern Section)

On the north east side from a point opposite the northern junction of the Pumphouse carpark for a distance of approximately 42 metres in a south-easterly direction to its junction with the Premier Inn carpark.

On the western side, fronting the eastern side of the Pumphouse, from a point 96 metres north of its junction with Ffordd-y-Mileniwm, for a distance of approximately 56.5metres in a north easterly direction
