(CAU DROS DRO) 2021**

<u>Llwybr</u>	Yn ystod y cyfnod cau hwn bydd gwyriadau wedi'u llofnodi drwy Cwrt Yr Ala Road a Llwybrau Troed Lecwydd Rhifau 5 a 7
<u>Rheswm</u>	Atal perygl i gerddwyr tra bod gwaith dymchwel ac ailadeiladu yn cael ei wneud.

**THE VALE OF GLAMORGAN COUNCIL
(LECKWITH PUBLIC FOOTPATH Nos 3 & 4)
(TEMPORARY CLOSURE) ORDER 2021**

On the 25th March 2021 the Vale of Glamorgan Council in exercise of its powers under Section 14 of the Road Traffic Regulation Act 1984 made an Order as described in the schedules below:

The Order shall come into force on 6th April 2021 and will be known as "The Vale of Glamorgan Council (Leckwith Public Footpath Nos 3 & 4) (Temporary Closure) Order 2021. If you wish to question the validity of the Order or any provisions contained therein on the grounds that they are not within the powers conferred by the above Act or on the grounds that any requirement of the same or that any instrument made under it has not been complied with in relation to the Order, you may within six weeks from the 6th March 2021 apply to the High Court for this purpose

SCHEDULE 1

No person shall proceed on foot in the locations specified in Schedule 2 below.

SCHEDULE 2

<u>Location</u>	Footpath (Public Rights of Way) known as Leckwith Numbers 3 & 4 from Orchard Cottage to Cwrt Yr Ala Road Michaelston Le Pit
<u>Alt. Route</u>	During this closure there will be signed diversions via Cwrt Yr Ala Road and Footpaths Leckwith Nos 5 & 7
<u>Reason</u>	To prevent danger to pedestrians while demolition & reconstruction work is carried out.
<u>Duration</u>	From 08.00 on Tuesday 6 th April 2021 for a maximum period of six Months or until works are completed whichever is the earlier. Dated this 25 th day of March 2021 Director of Environment & Housing Vale of Glamorgan Council, The Alps Depot, Wenvoe. CF5 6AA.
