<u>Llwybr</u>	Yn ystod y cyfnod cau hwn bydd gwyriadau gydag arwyddion drwy Readers Way
<u>Rheswm Hyd</u>	Atal perygl i gerddwyr tra bo gwaith ail-wynebu'n digwydd. O 08.00am ddydd Llun 8 Mawrth 2021 am gyfnod o chwe mis ar y mwyaf neu hyd nes y bydd y gwaith wedi'i gwblhau pa un bynnag yw'r cynharaf.

**THE VALE OF GLAMORGAN COUNCIL
(PENMARK PUBLIC FOOTPATH No21)
RHOOSE (TEMPORARY CLOSURE) ORDER 2021**

On the 4th March 2021 the Vale of Glamorgan Council in exercise of its powers under Section 14 of the Road Traffic Regulation Act 1984 made an Order as described in the schedules below:

The Order shall come into force on 8th March 2021 and will be known as "The Vale of Glamorgan Council (Penmark Public Footpath No 21) (Temporary Closure) Order 2021. If you wish to question the validity of the Order or any provisions contained therein on the grounds that they are not within the powers conferred by the above Act or on the grounds that any requirement of the same or that any instrument made under it has not been complied with in relation to the Order, you may within six weeks from the 4th March 2021 apply to the High Court for this purpose

SCHEDULE 1

No person shall proceed on foot in the locations specified in Schedule 2 below.

SCHEDULE 2

<u>Location</u>	Footpath (Public Rights of Way) known as Penmark Number 21 closed from Brendon View Close Rhosee to side of 13 Great Thomas Close Rhosee
<u>Alt. Route</u>	During this closure there will be signed diversions via Readers Way
<u>Reason</u>	To prevent danger to pedestrians while resurfacing work is carried out.
<u>Duration</u>	From 08.00am on Monday 8th March 2021 for a maximum period of six Months or until works are completed whichever is the earlier.
