

**The Vale Of Glamorgan Council  
(A48(Part), B4265(Part), B4270(Part) A4222 And Various Side Roads,  
Cowbridge And Llandow / Ewenny) (30mph 40mph And 50mph Speed Restriction  
Nd Revocation) Order 2021**

1. On the 17<sup>th</sup> January 2022 the Vale of Glamorgan Council in exercise of its powers under Sections 1,2 & 84 of the Road Traffic Regulation Act 1984 and of all other enabling powers made an Order the general effect of which is as described in the Schedules below.
2. The Order will come into operation on the 31<sup>st</sup> January 2022 or on the dates that the signs and road markings are in place, whichever is the later and shall be referred to as The Vale of Glamorgan Council ((A48(Part), B4265(Part), B4270(Part) A4222(Part) and Various Side Roads, Cowbridge and Llandow / Ewenny) (30mph 40mph and 50mph Speed Restriction and Revocation) Order 2021. 3. If you wish to question the validity of the Order or any provisions contained therein on the grounds that they are not within the powers conferred by the above Act or on the grounds that any requirement of the same or that any instrument made under it has not been complied with in relation to the Order, you may within six weeks from the 31<sup>st</sup> January 2022 apply to the High Court for this purpose.

**Schedule 1**

**Revoke the following speed restriction Orders in their entirety:**

**The Vale of Glamorgan Council (A48 (part), Ruthin Road (Part), Nash View, B4270 Llantwit Major Road (part) B4268 Llysworney Road (part)) (30, 40 and 50mph Speed Restriction and Revocation) Order 2019**

**The Vale of Glamorgan Council (Church Road (part), Cowbridge) (30mph and 40mph speed restriction) Order 2009**

**Schedule 2**

**No person shall cause or permit a vehicle to proceed at a speed greater than 30 miles per hour along the following lengths of roads:**

**Nash View, Pentre Meyrick**

From its junction with Ruthin Road, westwards for its entire length, a distance of approximately 48 metres.

**A48 (part), Cowbridge**

From a point 200 metres west of the centre its junction with the B4270 Llanfrynach Drive, eastwards for a distance of approximately 472 metres.

**B4270, Llanfrynach Drive and B4270, Llantwit Major Road (part), Cowbridge**

From the centre of its junction with the A48, in a generally southerly and then westerly direction, for a distance of approximately 1,450 metres.

From a point 329 metres southwest of the centre of its junction with Ysticl-Garu, north-eastwards for a distance of approximately 500 metres.

**Llantwit Major Road (part), Cowbridge**

From the termination of the 30mph speed restriction, located approximately 175 metres southwest of Darren Close, in a generally westerly direction to its junction with the B4270, Llanfrynach Drive, a distance of approximately 406 metres.

**Church Road (part), Llanblethian**

From a point approximately 50 metres northwest of the centre of its junction with Church View, north-westwards to its junctions with the B4270, Llantwit Major Road.

**Ysticl-Garu (part), Llysworney**

From its junction with the B4270, Llantwit Major Road, north-westwards for a distance of approximately 470 metres and contiguous with the 30 miles per hour restriction.

### Schedule 3

**No person shall cause or permit a vehicle to proceed at a speed greater than 40 miles per hour along the following lengths of roads:**

**A48 (part), Pentre Meyrick**

From a point 348 metres northwest of the centre of its junction with the B4268, south-eastwards for a distance of approximately 600 metres.

**Ruthin Road (part), Pentre Meyrick**

From its junction with the A48, northwards for a distance of approximately 160 metres.

**B4268 (part), Llysworney**

From the centre of its junction with the B4270, Llantwit Major Road, northwards for a distance of approximately 366 metres and contiguous with the 30mph speed restriction.

**B4270, Llantwit Major Road (part)**

From a point approximately 75 metres south of the centre of its junction with the Vale Business Park, in a generally northerly and then north-easterly direction for a distance of approximately 1,557 metres and contiguous with the 30mph speed restriction.

From a point approximately 171 metres northeast of the centre of its junction with Ysticl-Garu, north-eastwards for a distance of approximately 800 metres and contiguous with the 30mph speed restriction.

### Schedule 4

**No person shall cause or permit a vehicle to proceed at a speed greater than 50 miles per hour along the following lengths of roads:**

**A48 (part), Cowbridge**

From a point 348 metres northwest of the centre of its junction with the B4268, north-westwards for a distance of approximately 600 metres.

From a point 252 metres southeast of the centre of its junction with the B4268, south-eastwards for a distance of approximately 1,106 metres and contiguous with the 30mph speed restriction.

From a point 274 metres southeast of the centre of its junction with the B4270, Llanfrynach Drive, in a generally south-easterly direction for a distance of approximately 3,735 metres.

**A4222 (part), Darren Hill**

From its junction with the A4222, Gibbet's Hill, north-westwards to its on-slip junction with the westbound dual carriageway of the A48, Cowbridge Bypass, a distance of approximately 506 metres.

**A4222 (part), Gibbet's Hill**

From a point 65 metres north of its junction with Westgate and Llantwit Major Road, in a generally northerly and then easterly direction, to its junction with the eastbound carriageway of the A48, Cowbridge Bypass, a distance of approximately 480 metres.

**A4222 (part), Primrose Hill**

From its off-slip junction with the westbound dual carriageway of the A48, Cowbridge Bypass, in a south-westerly direction for a distance of approximately 130 metres.

From its on-slip junction with the eastbound dual carriageway of the A48, Cowbridge Bypass, in a north-westerly direction for a distance of approximately 100 metres.
