**THE VALE OF GLAMORGAN COUNCIL
(NANT TALWG WAY, BARRY)
(ROAD CLOSURE) (TEMPORARY) ORDER 2022**

On 5th April 2022 the Vale of Glamorgan Council in exercise of its powers under Section 14 of the Road Traffic Regulation Act 1984 made an Order the general effect of which is as described in the schedules below:

The Order will be known as "The Vale of Glamorgan Council (Nant Talwg Way, Barry) (Temporary) Order" 2022 and came into force on 6th April 2022.

If you wish to question the validity of the Order or any provisions contained therein on the grounds that they are not within the powers conferred by the above Act or on the grounds that any requirement of the same or that any instrument made under it has not been complied with in relation to the Order, you may within six weeks from the 7th April 2022 apply to the High Court for this purpose

SCHEDULE 1

No person shall proceed on foot or on a cycle at the location specified in Schedule 2 below.

SCHEDULE 2

Location: The area to be closed is the footpath lying between property Nos 42 and 44 Nant Talwg Way, Barry throughout it's length

Reason: As a result of damaged slabs and steps being a danger to the Public.

Duration: From 1.00pm on Wednesday 6th April 2022 for a maximum period of 6 Months

Alt. Route: Via the footpath lying between Nos 62 and 75 Nant Talwg Way, Barry
