**THE VALE OF GLAMORGAN COUNCIL
(PUBLIC BRIDLEWAY WELSH ST DONATS No27 & PENDOYLAN No24)
(TEMPORARY CLOSURE) ORDER 2022**

On the 5th April 2022 the Vale of Glamorgan Council in exercise of its powers under Section 14 of the Road Traffic Regulation Act 1984 made an Order as described in the schedules below:

The Order shall come into force on 18th April 2022 and will be known as "The Vale of Glamorgan Council (Public Bridleway Welsh St Donats No27 and Pendoylan No24) (Temporary Closure) Order 2022.

If you wish to question the validity of the Order or any provisions contained therein on the grounds that they are not within the powers conferred by the above Act or on the grounds that any requirement of the same or that any instrument made under it has not been complied with in relation to the Order, you may within six weeks from the 18th April 2022 apply to the High Court for this purpose

SCHEDULE 1

No person shall proceed on foot or horseback in the locations specified in Schedule 2 below.

SCHEDULE 2

Location	Bridleway (Public Rights of Way) known as Welsh St Donats No27 and Pendoylan No24
Alt. Route Reason	During this closure there will be signed diversions in place To prevent danger to pedestrians while civil engineering reconstruction work is carried out.
