**Rheswm:** Atal niwed posibl i bobl gan wal gynnal anniogel.

**Hyd:** O 00.01 ddydd Gwener 13 Mai 2022 am 18 mis ar y mwyaf

**Llwybr Arall:** Ar hyd y Sebra i ochr arall Broad Street ac i'r gwrthwyneb.

**THE VALE OF GLAMORGAN COUNCIL  
(BIRD CAGE WALK, BROAD STREET, BARRY)  
(ROAD CLOSURE) (TEMPORARY) ORDER 2022**

On 2<sup>nd</sup> May 2022 the Vale of Glamorgan Council in exercise of its powers under Section 14 of the Road Traffic Regulation Act 1984 made an Order the general effect of which is as described in the schedules below:

The Order will be known as "The Vale of Glamorgan Council (Bird Cage Walk, Broad Street, Barry) (Temporary) Order" 2022 and will come into force on 13<sup>th</sup> May 2022.

If you wish to question the validity of the Order or any provisions contained therein on the grounds that they are not within the powers conferred by the above Act or on the grounds that any requirement of the same or that any instrument made under it has not been complied with in relation to the Order, you may within six weeks from the 13<sup>th</sup> May 2022 apply to the High Court for this purpose

**SCHEDULE 1**

No person shall proceed on foot or on a cycle at the location specified in Schedule 2 below.

**SCHEDULE 2**

**Location:** The section of footway to be closed is 'Bird Cage Walk' Broad Street from the junction of Harbour Road to the Rail Station Zebra Crossing point on Broad Street, Barry.

**Reason:** To prevent potential injury to persons from an unsafe retaining wall.

**Duration:** From 00.01Hrs on Friday 13<sup>th</sup> May 2022 for a maximum period of 18 Months

**Alt. Route:** Across the Zebra to the opposite side of Broad Street and vice versa.
