**THE VALE OF GLAMORGAN COUNCIL
(ST ATHAN ROAD AND BROADWAY, COWBRIDGE)
(ROAD CLOSURE) (TEMPORARY) ORDER 2022**

1. On 5th April 2022 the Vale of Glamorgan Council in exercise of its powers under Section 14 of the Road Traffic Regulation Act 1984 made an Order the general Effect of which is as described in the schedules below:
2. The Order will be known as “The Vale of Glamorgan Council (St Athan Road And Broadway) (Road Closure) (Temporary) Order” 2022 and will come into force on Monday 11th April 2022.

SCHEDULE 1

No person shall cause or permit a motor vehicle to proceed in the location specified In Schedule 2 below.

SCHEDULE 2

- Location 1:** The road to be closed is **St Athan Road, Cowbridge** to North Bound traffic only from the junction of Brookfield Park Road to the junction of Broadway.
- Location 2:** The road to be closed is **Broadway, Cowbridge** to West Bound traffic from the junction of St Athan Road to the junction of Aubrey Terrace.
- Reason:** To allow for Gas Main replacement Works to be undertaken.
- Duration:** From 8.00am on Monday 11th April 2022 until 6.00pm on Friday 27th May 2022 or until the works are completed whichever is the earlier.
- Alt. Route:** Local signed diversions will be in place via Brookfield Park Road.
- NB:** Access will be maintained for Residents and Emergency Services and Pedestrian access will remain in place at all times.
