**THE VALE OF GLAMORGAN COUNCIL
(PROHIBITION AND RESTRICTION OF WAITING AND LOADING AND PARKING PLACES)
(CIVIL ENFORCEMENT) (AMENDMENT) (NO 1) ORDER 2022**

1. Notice is given that the Vale of Glamorgan Council in exercise of its powers under the Road Traffic Regulation Act 1984 and the Traffic Management Act 2004 and of all other enabling powers proposes to make an Order to install parking restrictions specified in the Schedule below.
