

## COMMONS ACT 2006 - SECTION 15(1)

### Notice of an application for the registration of land as a Town or Village Green

To every reputed owner, lessee, tenant or occupier of any part of the land described below, and to all others whom it may concern.

Application has been made to the Vale of Glamorgan Council ('the Registration Authority') by Save Sully and Lavernock Group under section 15(1) of the Commons Act 2006 and in accordance with the Commons (Registration of Town or Village Greens) (Interim Arrangements) (Wales) Regulations 2007.

The application seeks the inclusion in the register of town and village greens of the land described in the Schedule below which is claimed to have qualified for registration as a town or village green by virtue of the use of the area for lawful sports and pastimes as of right for more than 20 years prior to the date of the application and continue to do so at the time of the application.
