PUBLIC PATH DIVERSION ORDER 2022

On the 28 February 2023 the Vale of Glamorgan Council confirmed the above Order made under section 119 of the Highways Act 1980.

The effect of the Order as confirmed is to divert the public as set out in the Schedule and shown in the Order map.

A copy of the Order as confirmed and the Order map have been placed and may be seen free of charge at the Civic Offices, Holton Road, Barry, Vale of Glamorgan CF63 4RU. Copies of the order and map may be bought at a price of £4.50.

This Order comes into force on 28 February 2023, but if a person aggrieved by the Order wants to question its validity, or that of any provision contained in it, on the ground that it is not within the powers of the Highways Act 1980, as amended, or on the ground that any requirement of the Act, as amended, or of any regulation made under the Act has not been complied with in relation to the Order, he or she may, under paragraph 2 of Schedule 2 to the Act as applied by paragraph 5 of Schedule 6 to the Act, within 6 weeks from 09 March 2023 make an application to the High Court.

PUBLIC PATH DIVERSION ORDER 2022

This Order is made by the Vale of Glamorgan Council ("the Authority") under Section 119 of the Highways Act 1980 ("the 1980 Act") because it appears to the Authority that in the interests of the owner of the land crossed by the footpath described in paragraph 1 of this Order it is expedient that the line of the path should be diverted.

BY THIS ORDER

1. The public right of way over the land situate at Trehedyn House, Peterston-super-Ely and shown by a bold continuous line on the map contained in this Order and described in Part 1 of the Schedule to this Order shall be stopped up after 28 days from the date of confirmation of this Order.
2. Notwithstanding this Order any statutory undertaker having apparatus in, on, over, along or across the land referred to in paragraph 1 for the purpose of carrying on their undertaking shall have the same rights in respect of the apparatus as they had immediately before the date on which the footpath was diverted.
3. There shall at the end of 28 days from the date of confirmation of this Order be an alternative footpath over the land situate at Trehedyn House, Peterston-super-Ely described in Part 2 of the Schedule and shown by a bold broken line on the map contained in this Order.
4. The rights conferred on the public under this Order shall be subject to the limitations and conditions set out in Part 3 of the Schedule.

A – D – E – C Footpath N^o 26 Pendoylan	Commences at point A (NGR 306867 175525) and proceeds northward parallel to a hedgerow on the east side of the hedgerow to point D (NGR 306870 175575). The path continues northwards parallel to a fenceline on the east side of the fenceline to point E (NGR 306871 175590). The path turns eastwards parallel to a fenceline on the south side of the fenceline which itself runs parallel to a hedgeline on the south side of the hedgeline. The path continues eastwards skirting to the south of an oil storage tank before swinging north-eastwards to terminate at a gate at point C (NGR 306907 175595).	105 metres	2 metres

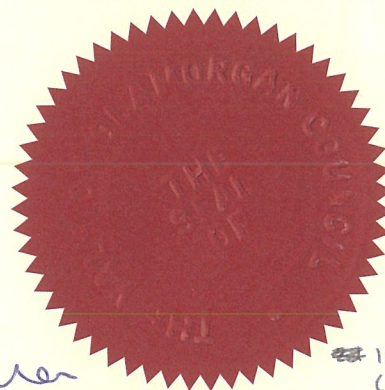
