PUBLIC PATH DIVERSION ORDER 2023

The above order, made on the 1 June 2023, under Section 119 of the Highways Act 1980, will divert the public footpaths that intersect close to Llypot Farm, Bonvilston NGR 306063 174835 to an alignment running parallel to the property's boundary as shown on the Order map.

A copy of the order and the order map have been placed and may be seen free of charge at The Docks Office, Barry Docks, Barry, CF63 4RT during normal office hours. Copies of the order and map may be bought there at the price of £4.50.

Any representations about or objections to the order may be sent in writing to the Head of Regeneration and Planning, Docks Office, Barry Docks, Barry, CF63 4RT not later than the 13 July 2023. Please state the grounds on which they are made.

If no such representations or objections are duly made, or if any so made are withdrawn, the Vale of Glamorgan Council may confirm the order as an unopposed order. If the order is sent to the Welsh Ministers for confirmation any representations and objections which have not been withdrawn will be sent with the order.

PUBLIC PATH DIVERSION ORDER 2023

This Order is made by the Vale of Glamorgan Council ("the Authority") under Section 119 of the Highways Act 1980 ("the 1980 Act") because it appears to the Authority that in the interests of the owner of the land crossed by the footpath described in paragraph 1 of this Order it is expedient that the line of the path should be diverted.

BY THIS ORDER

1. The public right of way over the land situate at Lilypot Farm, Bonviston and shown by a bold continuous line on the map contained in this Order and described in Part 1 of the Schedule to this Order shall be stopped up after 28 days from the date of confirmation of this Order.
2. Notwithstanding this Order any statutory undertaker having apparatus in, on, over, along or across the land referred to in paragraph 1 for the purpose of carrying on their undertaking shall have the same rights in respect of the apparatus as they had immediately before the date on which the footpath was diverted.
3. There shall at the end of 28 days from the date of confirmation of this Order be an alternative footpath over the land situate at Lilypot Farm, Bonviston described in Part 2 of the Schedule and shown by a bold broken line on the map contained in this Order.
4. The rights conferred on the public under this Order shall be subject to the limitations and conditions set out in Part 3 of the Schedule.

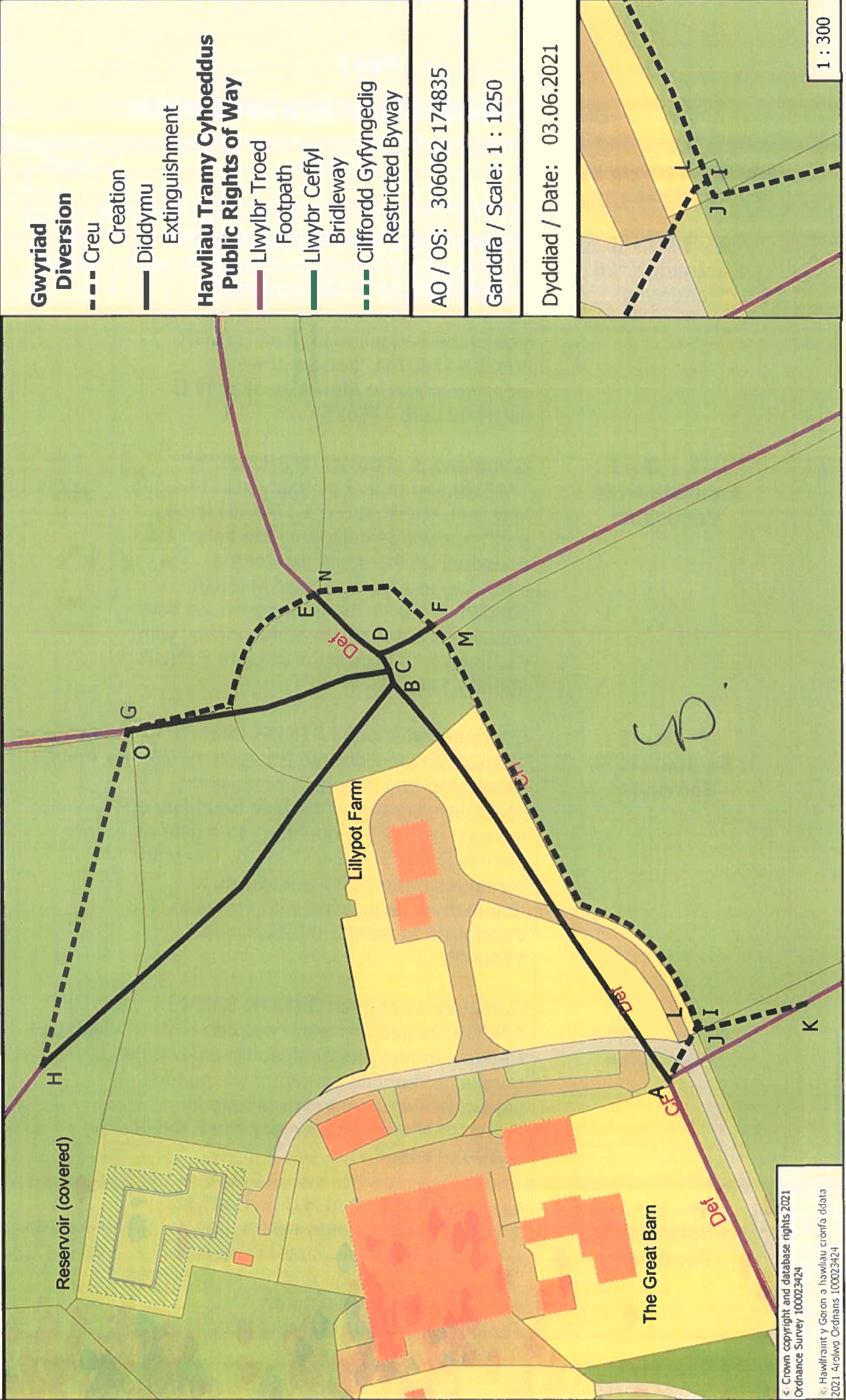

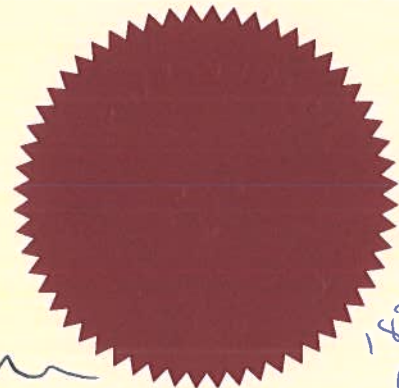
