PUBLIC PATH DIVERSION ORDER 2024**

The above order, made on the 31st October, 2024, under Section 119 of the Highways Act 1980, will divert public footpath No.6 St Donats running from NGR 293849 167907 and proceeds eastwards to NGR 293887 167917 to a line running from NGR 293849 167907 north-eastwards then eastwards to terminate at NGR 293899 167936 also public footpath No.5 St Donats running from NGR 293887 167917 eastwards to NGR 294011 167905 to a line running from NGR 293899 167936 eastwards to NGR 293972 167933 then the path turns south-eastwards to NGR 294009 167904 then eastwards to NGR 294011 167904 as shown on the Order map.
