**THE VALE OF GLAMORGAN COUNCIL DEFINITIVE MAP MODIFICATION ORDER 2025 (NO.DMO/53/039)**

The above Order made on 28<sup>th</sup> January 2025 if confirmed as made, will modify the Definitive map and Statement for the area by adding a Restricted Byway running from the adopted highway at Boerton Mill Farm (NGR 299213 167309) in a southerly direction along the access track to meet Public Footpath N<sup>o</sup>.3 Llantwit Major (NGR 299372 166663) as shown on the Order map.

Any representations about or objections to the Order may be sent in writing to the Head of Regeneration and Planning, The Docks Office, Subway Road, Barry, Vale of Glamorgan CF63 4RT not later than the 10th July 2025. Please state the grounds on which they are made.

If no such representations or objections are duly made, or if any so made are withdrawn, the Vale of Glamorgan Council may confirm the Order as an unopposed order. If the Order is sent to the Welsh Ministers for confirmation any representations and objections which have not been withdrawn will be sent with the Order.
