### **The Definitive Map and Statement for the County of Vale of Glamorgan Relevant Date 15<sup>th</sup> March 2016**

### **The Vale of Glamorgan Council Definitive Map (Modification) Order 2025 (No.DMO/53/039)**

This Order is made by The Vale of Glamorgan Council ("the Authority") under section 53(2)(b) of the Wildlife and Countryside Act 1981 ("the Act") because it appears to the Authority that the Definitive Map and Statement for the County of Vale of Glamorgan, Relevant Date 15<sup>th</sup> March 2016, require modification in consequence of the occurrence of an event specified in section 53(3)(c)(i), namely, the discovery by the Authority of evidence which (when considered with all other relevant evidence available to them) shows that a right of way which is not shown in the map and statement subsists or is reasonably alleged to subsist over land in the area to which the map relates, being a right of way such that the land over which the right subsists is a Restricted Byway.

The Authority has consulted with every local authority whose area includes the land to which the Order relates.

The Authority hereby orders that:

1. For the purposes of this Order the relevant date shall be *20<sup>th</sup> November 2024*
2. The Definitive Map and Statement of Public Rights of Way for the County of Vale of Glamorgan, Relevant Date 15<sup>th</sup> March 2016, shall be modified as described in Part I and Part II of the Schedule hereto and shown on the map attached to the Order.
3. This Order shall take effect on the date it is confirmed and may be cited as the Vale of Glamorgan Definitive Map (Modification) Order 2025 (No. DMO/53/039)

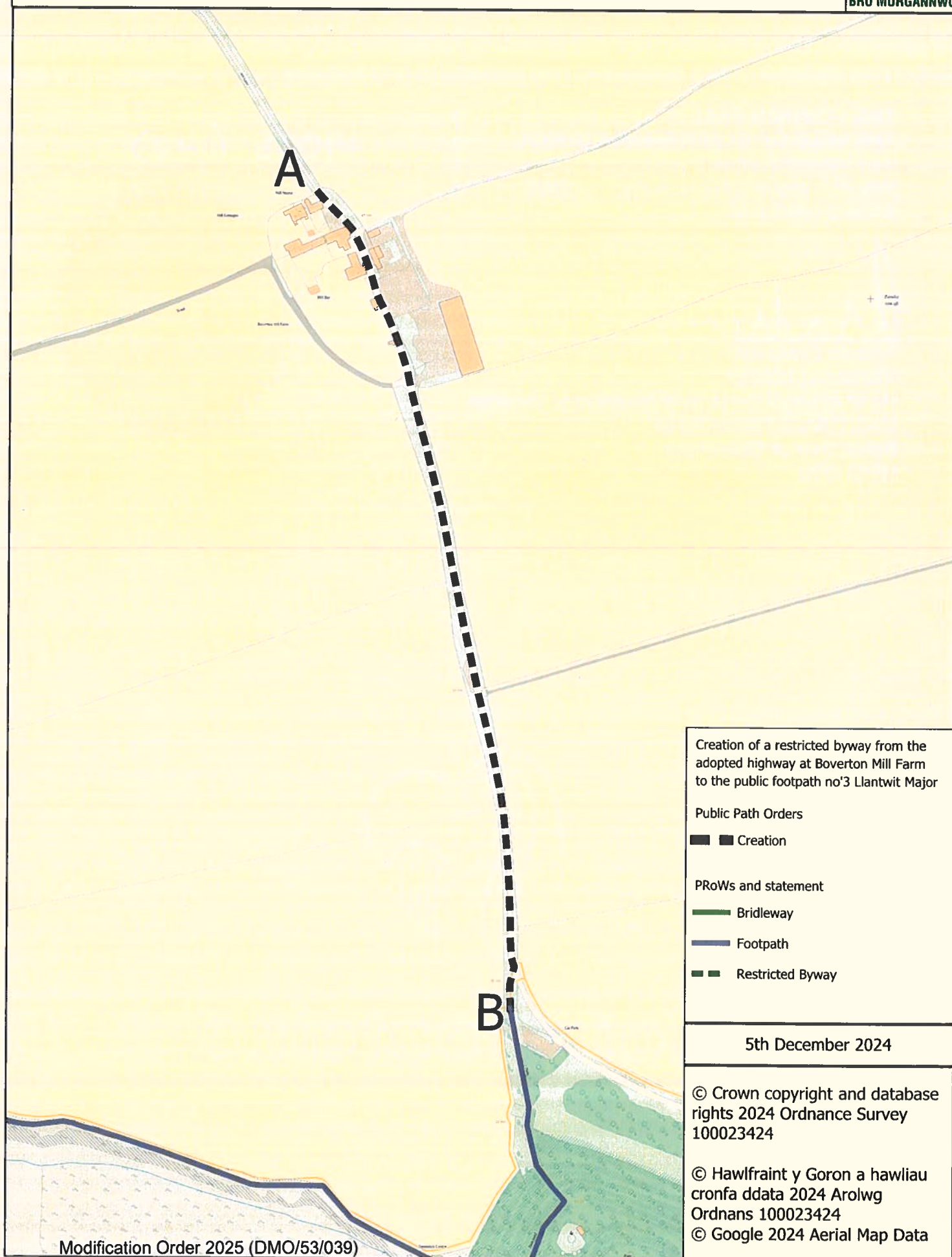
