

**THE VALE OF GLAMORGAN COUNCIL  
(PROHIBITION AND RESTRICTION OF WAITING AND  
LOADING AND PARKING PLACES) (CIVIL ENFORCEMENT)  
(AMENDMENT) (NO 4) ORDER 2026**

1. On the \_\_\_\_\_ 2026 The Vale of Glamorgan Council in exercise of its powers under the Road Traffic Regulation Act 1984 and the Traffic Management Act 2004 and all other enabling powers made an Order to install the Parking Restrictions specified in the schedule below.
2. The Order will come into operation on \_\_\_\_\_ 2026 or on the dates that the signs and road markings are installed whichever is the later and be known as the “Vale of Glamorgan Council (Prohibition and Restriction of Waiting and Loading and Parking Places) (Civil Enforcement) (Amendment) (No 4) Order 2026”

If you wish to question the validity of the Order or any provisions contained therein on the grounds that they are not within the powers conferred by the above Act or on the grounds that any requirement of the same or that any instrument made under it has not been complied with in relation to the Order, you may within six weeks from the \_\_\_\_\_ 2026 apply to the High Court for this purpose.

**Vale of Glamorgan Council Off Street Parking Places (Civil Enforcement) (Amendment) Order 2025**

**SCHEDULE 2**

**The following shall be added to the above Traffic Regulation Orders**

In ‘Interpretation’ Add the following:

**‘Free Parking Period’** The Free Parking Period shall be a maximum period of 2 hours or any other period as referred to in the order or on the charges information signs within the car park.

Following the expiry of the free parking period, vehicles shall depart the car park with no return within 2 Hours.

Alternatively, the vehicle may remain in the car park following the expiration of the Free Parking Period provided the appropriate parking charge is paid in accordance with the order and Charges information signs within the car park.
