

**THE VALE OF GLAMORGAN COUNCIL
(PROHIBITION AND RESTRICTION OF WAITING AND
LOADING AND PARKING PLACES) (CIVIL ENFORCEMENT)
(AMENDMENT) (NO 5) ORDER 2025**

1. On the 4th August 2025 The Vale of Glamorgan Council in exercise of its powers under the Road Traffic Regulation Act 1984, Road Traffic Act 1988 and the Traffic Management Act 2004 and all other enabling powers made an Order to amend the Parking Restrictions specified in the schedules below.
2. The Order will come into operation on 11th August 2025 or on the dates that the signs and road markings are installed or removed whichever is the later and be known as the “Vale of Glamorgan Council (Prohibition and Restriction of Waiting and Loading and Parking Places) (Civil Enforcement) (Amendment) (No 5) Order 2025”
3. A copy of the Order and plans showing the affected area may be inspected on the Council’s website at www.valeofglamorgan.gov.uk
4. If you wish to question the validity of the Order or any provisions contained therein on the grounds that they are not within the powers conferred by the above Act or on the grounds that any requirement of the same or that any instrument made under it has not been complied with in relation to the Order, you may within six weeks from the 11th August 2025 apply to the High Court for this purpose.

SCHEDULE 1

The following Traffic Regulation Order is to be amended as follows:

Vale of Glamorgan Council (Prohibition and Restriction of Waiting and Loading and Parking Places) (Civil Enforcement) Order 2013

Prohibition of Waiting At Any Time

George Street (part), Barry

On both sides from the junction with Dock View Road, in a north westerly direction for a distance of approximately 10 metres.

Dock View Road (part), Barry

On the northwest side from the junction with George Street, in a south westerly direction for a distance of approximately 10 metres.

On the northwest side from the junction with George Street, in a north easterly Direction for a distance of approximately 10 metres.

On the southeast side from a point 10 metres southwest of the southwestern side of George Street, north eastwards for a distance of approximately 28 metres.

Proposed Revocation of existing Prohibition of Waiting At Any Time

George Street (part), Barry

On the southwest side from the junction with Dock View Road, in a north westerly direction for a distance of 28.3 metres.

On the northeast side from the junction with Dock View Road, in a north westerly direction for a distance of 26.5 metres

Dock View Road (part), Barry

On the northwest side from junction with George Street, in a north easterly direction for a distance of 38 metres.

On the northwest side from the junction with George Street, in a south westerly direction for a distance of 12.7 metres.

On the southeast side from the boundary line between property numbers 72 and 73 in a north easterly direction for a distance of 51 metres.
