**ROUTE A4050, PORT ROAD(PART), WENVOE – PROPOSED BUS LANE ORDER AND**  
**ROUTE A4055, CARDIFF ROAD(PART), LLANDOUGH – AMENDMENT OF EXISTING BUS**  
**LANE ORDER 2026**

1. Notice is given that the Vale of Glamorgan Council in exercise of its powers under the Road Traffic Regulation Act 1984 and of all other enabling powers proposes to make an Order as specified in the Schedules below.
2. 3. Persons objecting to the proposed Order are advised that in view of the Local Government (Access to Information) Act 1985 this Council is legally obliged to make any comments received in response to the proposed Order open to public inspection.

**SCHEDULE 1**

**Route A4050, Port Road(part), Wenvoe**

On the northwest side from a point 187 metres southwest of the centre of its junction with the route A4231, Barry Dock Link Road roundabout, in a generally northerly direction for a distance of approximately 360 metres.

On the western side from a point 53 metres north of the centre of its junction with Nant Isaf, in a northerly direction for a distance of approximately 449 metres.

On the western side from a point 25 metres north of the centre of its junction with the Quarry Road roundabout, in a generally northerly direction for a distance of approximately 527 metres.

On the western side, from its junction with St Lythans Road, in a northerly direction for a distance of approximately 157 metres.

**(Buses, Motorcycles and Taxis will be exempt from the Order).**

**SCHEDULE 2**

**Route A4055, Cardiff Road(part), Llandough**

**Amend paragraph 2.1 of the restrictions, contained within Part II of the following Traffic Order (listed as Order 891):**

**THE VALE OF GLAMORGAN COUNCIL (CARDIFF ROAD, DINAS POWYS) (COMBINED FOOTWAY / CYCLE LANE AND BUS LANE) ORDER 2008**

**To read:**

No person shall cause or permit any vehicle other than a bus, motorcycle or taxi to proceed at any time along the with-flow Bus Lane, as described in Schedule 1 below, and
