

**THE VALE OF GLAMORGAN COUNCIL  
(PROHIBITION AND RESTRICTION OF WAITING AND  
LOADING AND PARKING PLACES) AND PROHIBITION OF  
OVERNIGHT PARKING AND STOPPING  
(CIVIL ENFORCEMENT) (AMENDMENT) (NO 4) ORDER 2025**

1. Notice is given that the Vale of Glamorgan Council in exercise of its powers under the Road Traffic Regulation Act 1984 and the Traffic Management Act 2004 and of all other enabling powers proposes to make an Order to amend the parking restrictions at the locations specified in the Schedules below.
2. 3. Persons objecting to the proposed Order are advised that in view of the Local Government (Access to Information) Act 1985 this Council is legally obliged to make any comments received in response to the proposed Order open to public inspection.

The following Traffic Regulation Order is to be amended as follows:

**SCHEDULE**

**Map Schedules AN65 AO65 AP65 AP64 AQ65 AR65 - Penarth**

**Proposed Prohibition of Overnight Parking and Stopping of Motorhomes, Motor Caravans and Campervans - 6pm until 8am 7 Days a Week**

**Plymouth Road**

From its junction with Raisdale Road to its junction with Forrest Road, in a southerly direction for a distance of approximately 408 metres.

**Craven Walk**

From its junction with Knowbury Avenue to its junction with Whitcliffe Drive, in a easterly direction for a distance of approximately 90 metres.

**Forrest Road**

From its junction with Plymouth Road to the cul-de-sac end, in a easterly direction for a distance of approximately 173 metres.

**Stanton Way**

From its junction with Knowbury Avenue to its junction with Whitcliffe Drive, in a north easterly direction for a distance of approximately 95 metres.

Cliff Side  
The Paddocks  
Whitcliffe Drive
