

**NOTICE OF CONFIRMATION OF PUBLIC PATH ORDER  
TOWN AND COUNTRY PLANNING ACT 1990**

**THE VALE OF GLAMORGAN COUNCIL**

**(PUBLIC FOOTPATH NO 43 LLANTWIT MAJOR)  
PUBLIC PATH DIVERSION ORDER 2018**

On the 8<sup>th</sup> February, 2019 the Vale of Glamorgan Council confirmed the above Order made under section 257 of the Town and Country Planning Act 1990.

The effect of the Order will be to divert the public footpath running from the adopted highway (Boverton Road) (NGR 298576 168444) to the adopted highway (B4265) NGR 298577 168556 and create an alternative footpath on a line running from the adopted highway (Boverton Road) NGR 298576 168444 to the adopted highway (B4265) NGR 298605 168534 as shown on the Order map.

A copy of the Order as confirmed and the Order map may be seen free of charge at the Docks Office, Subway Road, Barry, Vale of Glamorgan CF63 4RT during normal office hours. Copies of the Order and Order map may be bought there at the price of £4.50.

This Order comes into force on 8<sup>th</sup> February, 2019 but if any person aggrieved by the Order desires to question its validity or that of any provision contained in it on the ground that it is not within the powers of the Town and Country Planning Act, or on the ground that any requirement of that Act or any regulation made under it has not been complied with in relation to the confirmation of the Order, he or she may, under section 287 of the Act within 6 weeks from the date on which notice is first published as required by paragraph 7 of Schedule 14 to the Act, make an application to the High Court.
