PUBLIC PATH CREATION ORDER 2019**

The above Order, made on the 11th April 2019, under Section 26 of the Highways Act 1980, will create a public footpath from Bolgoed Farm, Hensol (NGR 304078 179633) along a track to Fforest Fach Farm, Hensol (NGR 303902 179699), as shown on the Order map.

If no such representations or objections are duly made, or if any so made are withdrawn, the Vale of Glamorgan Council may confirm the Order as an unopposed order. If the Order is sent to the Welsh Ministers for confirmation any representations and objections which have not been withdrawn will be sent with the Order.

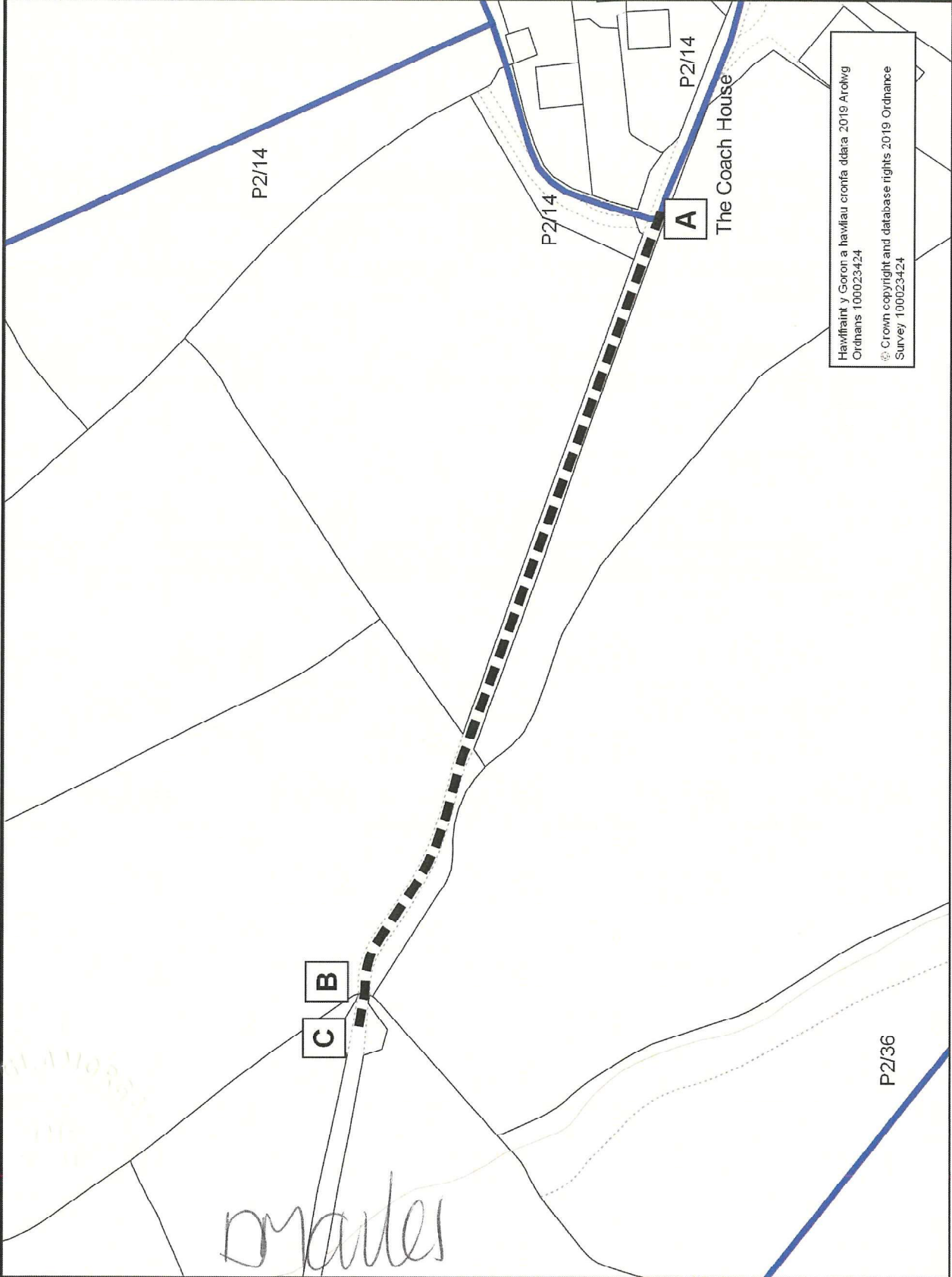
