PUBLIC PATH DIVERSION ORDER 2019**

The above Order, made on the 11th April 2019, under Section 119 of the Highways Act 1980, will divert the following public footpaths; N^o.336 Llantrisant running from Coed Gellihir Isaf (NGR 303718 180266) to the parish boundary west of Pantaquesta Farm (NGR 303771 179837) to a line running from Coed Gellihir Isaf (NGR 303718 180266) to the parish boundary (NGR 303811 179835), N^o.339 Llantrisant running from Pantaquesta Farm (NGR 304003 179902) to the adopted highway (NGR 304371 180027) to a line running from south of Pantaquesta Farm (NGR 304057 179801) to the adopted highway (NGR 304384 179963), N^o.36 Pendoylan running from north-west of Cefn Llys (NGR 303947 179528) to Fforest Fach Farm (NGR 303641 179760) to a line running from north-west of Cefn Llys (NGR 303947 179528) to Fforest Fach Farm (NGR 303641 179760) and N^o.37 Pendoylan running from Fforest Fach Farm (NGR 303764 179759) to the parish boundary (NGR 303771 179837) to a line running from the access road leading to Fforest Fach Farm ((NGR 303902 176699) to the parish boundary (NGR 303811 179835), as shown on the Order map.

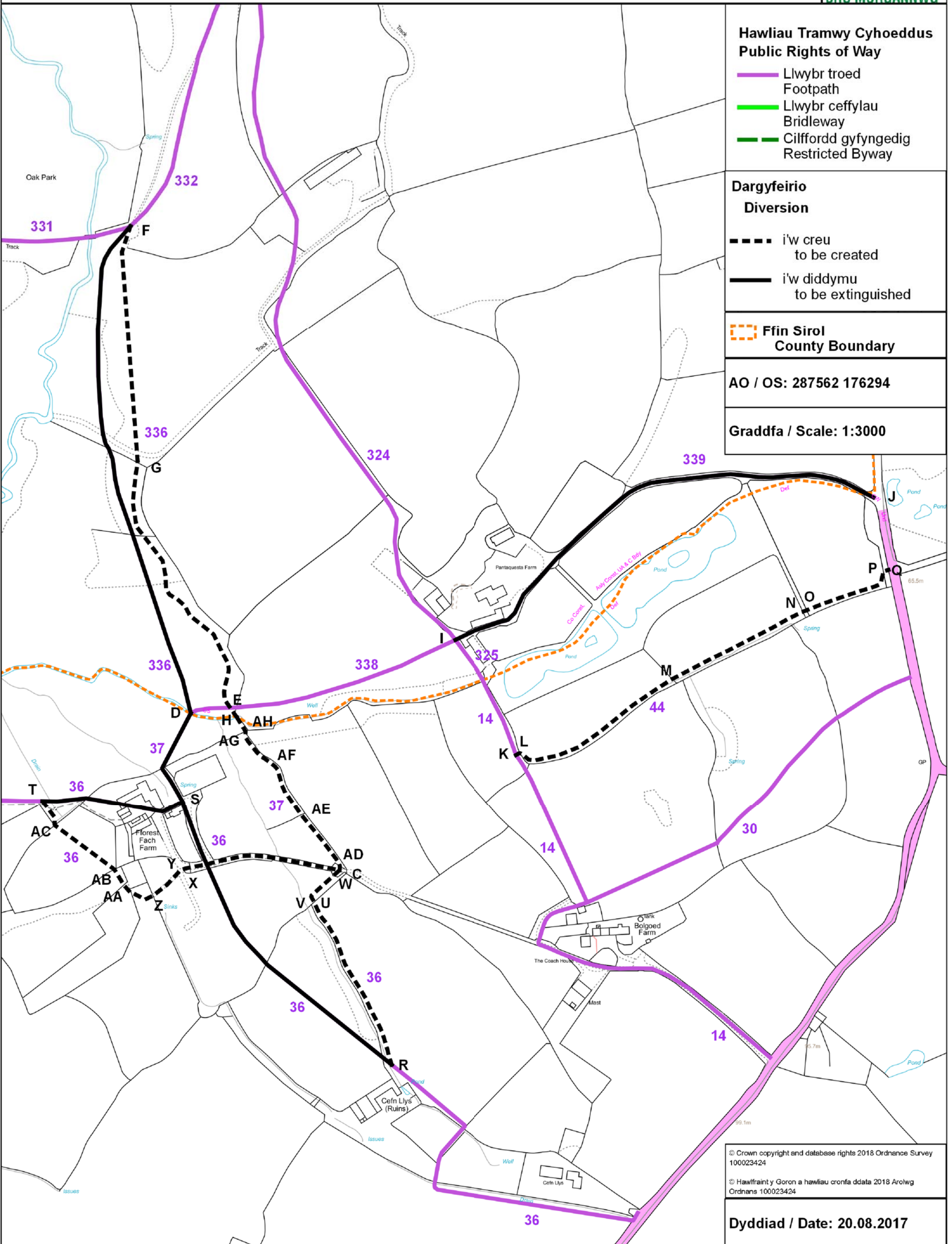
