The above Order, made on the 11th April 2019, under Section 118 of the Highways Act 1980, will extinguish the public footpath running from NGR 303771 179837) to (NGR 303806 179842) crossing land to the west of Pantaquesta Farm, Hensol as shown on the Order map.

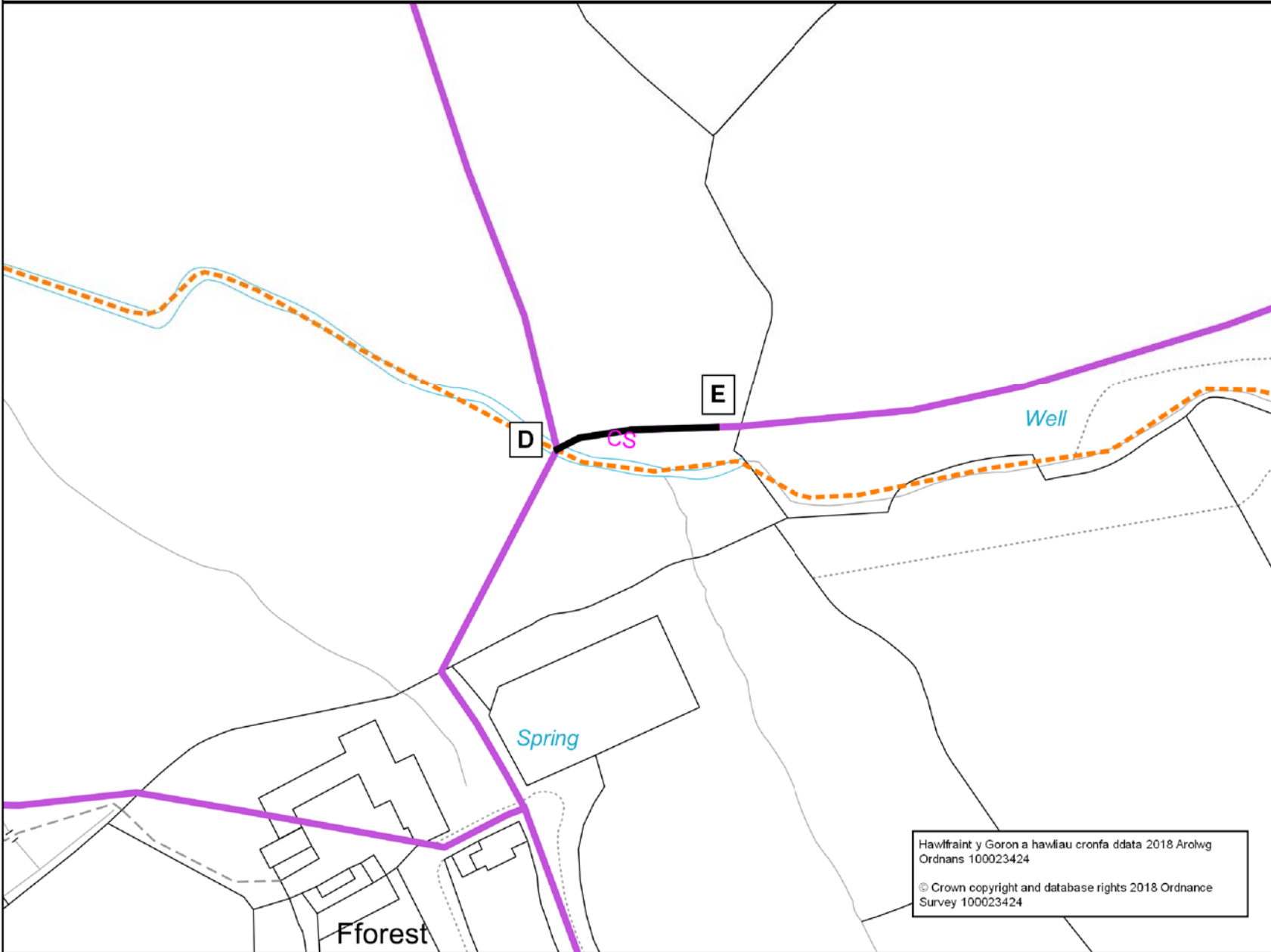

If the Order is sent to the Welsh Ministers for confirmation any representations and objections which have not been withdrawn will be sent with the Order.
