

**NOTICE OF MAKING OF AN ORDER**

**PUBLIC PATH DIVERSION ORDER 2019**

The above Order, made on the 18<sup>th</sup> July 2019, under Section 119 of the Highways Act 1980, will divert the public footpath running from the adopted highway NGR 306101 175861, passing close to the residential property Caerwigau Isaf to a line running from the adopted highway south-westwards parallel to the original alignment through a field to re-join the original alignment at NGR 306000 175758 as shown on the Order map.

Any representations about or objections to the Order may be sent in writing to the Head of Regeneration and Planning, Docks Office, Subway Road, Barry, Vale of Glamorgan CF63 4RT not later than the 5<sup>th</sup> September 2019 Please state the grounds on which they are made.

If no such representations or objections are duly made, or if any so made are withdrawn, the Vale of Glamorgan Council may confirm the Order as an unopposed order. If the Order is sent to the Welsh Ministers for confirmation any representations and objections which have not been withdrawn will be sent with the Order.
