

**NOTICE OF CONFIRMATION OF PUBLIC PATH ORDER  
HIGHWAYS ACT 1980**

**THE VALE OF GLAMORGAN COUNCIL**

**(PUBLIC FOOTPATH N<sup>o</sup>. 338 LLANTRISANT)  
PUBLIC PATH EXTINGUISHMENT ORDER 2019**

On the 16<sup>th</sup> July 2019 the Vale of Glamorgan Council confirmed the above Order made under section 118 of the Highways Act 1980.

The effect of the Order as confirmed is to extinguish the public footpath running from NGR 303771 179837 to NGR 303806 179842 crossing land to the west of Pantaquesta Farm, Hensol as set out in the Schedule and shown in the Order map.

A copy of the Order as confirmed and the Order map have been placed and may be seen free of charge at the Docks Office, Subway Road, Barry, Vale of Glamorgan CF63 4RT. Copies of the Order and map may be bought there at a price of £4.50.

This Order comes into force on 16<sup>th</sup> July 2019, but if a person aggrieved by the Order wants to question its validity, or that of any provision contained in it, on the ground that it is not within the powers of the Highways Act 1980, as amended, or on the ground that any requirement of the Act, as amended, or of any regulation made under the Act has not been complied with in relation to the Order, he or she may, under paragraph 2 of Schedule 2 to the Act as applied by paragraph 5 of Schedule 6 to the Act, within 6 weeks from 8<sup>th</sup> August 2019 make an application to the High Court.
